I, ~~Bikash~~<sup>Bikash</sup> Kumar Sharma, resident of Tirumala  
Apartment, Near Isabella High School was travelling  
from Scooty no. WB 74 BL 1968 when suddenly  
a truck (No- WB 73 D 8353) from wrong side  
ran over my Scooty & then my left leg on  
30/08/2023 around 9:00 pm. The driver fled with  
the truck after hitting me. It is with the  
help of local people who were present there, they  
chased the vehicle for about 1 km and caught  
hold of the driver. It was found that the  
driver was under toxication and was even unable  
to communicate properly. We somehow managed to  
take the contact number of the truck ~~owner~~<sup>owner</sup> (Mr. Ashok Garg,  
resident of Sky View Apartment, Sitiguri Sevoke Road) and  
tried reaching him several times. My neighbours & relatives  
tried calling him several times seeking for help  
but he did not respond properly. In the meantime,  
I was admitted to Hill Point Nursing Home, Mallaguri,  
Sitiguri by my relatives & friends. After half an hour  
his staff Mr. Binod Mahato with 3-4 local goons  
came on spot and tried to forcibly take away the  
truck. I could not register a complaint as I was  
~~at~~ under treatment in hospital on from 30/08/2023 to 02/09/2023  
and my family & friends were also engaged in  
the hospital.
