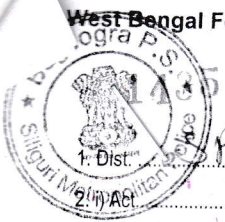

I, the under signed would like lodge that as per source information, on 01.09.2023 at about 15:05 hours being the I.O. of the case, a raid was conducted in the flat No.406 "B" Block located at Uttora Housing Complex, with information to local PS, ie Bagdogra PS in c/w with Chopra PS Case No. 632/23 dtd 22.08.2023 u/s 448/323/324/325/326/307/354/427/436/379/506/34 IPC R/W 25(1)(a)/27 arms act and Sec. 3 (1)(x) Schedule Castes & Schedule Tribes (POA) Act 1989 with a view to arrest the FIR named accused persons as well as to collect evidences. During raid the FIR named accused Mushiruddin @ Moulabi S/O- Md Hamiruddin of Vill- Dhuliagachh, PO- Ghorugachh, PS - Chopra, Dist- Uttar Dinajpur and Anamul S/O- Ashiruddin of Vill+PO- Bhaispita, PS- Chopra, Dist- Uttar Dinajpur were found absconding from there. On being searched it was noticed that the flat was owned by FIR named accused Anamul and the flat was kept sealed in view of evidentiary purpose and further search and seizure. Security guards of Uttarayan housing complex were briefed properly in this regard. This refers to Chopra PS GDE No. 25 & 29 dtd. 01.09.2023.

On the same day at about 19:05 hrs an information was received from the security guard named Tapas Kumar (90937 06940) of the housing complex located at "Uttora" that the FIR named accused Mushiruddin @ Moulabi S/O- Md. Hamiruddin of Vill- Dhuliagachh, PO- Ghorugachh, PS - Chopra, Dist- Uttar Dinajpur and Anamul S/O- Ashiruddin of Vill+PO- Bhaispita, PS- Chopra, Dist- Uttar Dinajpur came at the said housing campus and opened the sealed flat after breaking it's seal with a view to damage or destroy the evidences kept inside the sealed flat. Accordingly when the on duty security guard chased them, they managed to flee away after showing fire arms leaving their vehicle No. WB12AS- 3386. On getting such information, a police team of Chopra PS rushed to the spot with the help of Bagdogra PS and seized the said vehicle having No- WB 12AS/3386 (Maruti Celerio) and it was brought to Chopra PS. This is noted in GD vide Chopra PS GDE No. 38 & 47 dt. 01.09.2023,

I therefore pray that necessary legal steps may please be taken treating this as FIR against the above noted accused persons for breaking of seal and to destroy the evidences of the above mentioned case.
