I, the under singed would like lodge that as per source information, on 01.09.2023 at about 15:05 hours being the I.O. of the case, a raid was conducted in the flat No.406 "B" Block located at Uttora Housing Complex, with information to local PS,ie Bagdogra PS in c/w with Chopra PS Case No. 632/23 dtd 22.08.2023 u/s 448/323/324/325/326/307/354/427/436/379/506/34 IPC R/W 25(I)(a)/27 arms act and Sec. 3 (1)(x) Schedule Castes & Schedule Tribes (POA) Act 1989 with a view to arrest the FIR named accused persons as well as to collect evidences. During raid the FIR named accused Mushiruddin @ Moulabi S/O- Md Hamiruddin of Vill- Dhuliagachh, PO-Ghorugachh, PS – Chopra, Dist- Uttar Dinajpur and Anamul S/O- Ashiruddin of Vill+PO- Bhaispita, PS- Chopra, Dist- Uttar Dinajpur were found absconding from there.
