I Dalia Roy, W/o. Debjit Munshi, presently residing at Collegepara, Siliguri near Baghajatin Park.


That on today i.e. 03/09/2023 exactly 12.35pm and 12.41pm I received some ph calls from 9434207549 & 9382938143 numbers respectively to my number 9083622266. Over the phone one unknown person at first enquired about my husband as he was sick and admitted in Paramount hospital few days ago, I couldn't get about the person clearly and asked for his identity, then he disclosed his identity as my husband's cousin brother namely Prasenjit calling from Siliguri as my husband doesn't have any relative namely the same. Then I asked what does he want and for what reason he has called me? Then he offered me over phone some money 10000 bucks. And started to threaten with dire consequences and abuses by very cheap, filthy and abusive languages which hammer the dignity and modesty of me. Whenever I was about to raise an objection, the suspective person attacked my husband personally and said that he is a cheater, fraud and thief he will see us and do very terrified in the road anywhere he will see us and he would kill us.

That we are passing our day and life very insecurely about these suspective phone calls and threat. Finding no other alternative knocking at your door please do the needful and obliged.
