I, Smt. Dipa Bala, Wife of Swapan Bala, resident of No.1-Jyoti Nagar Colony,
Near Siliguri Jaikhana, Ward No. 20 of S.M.C. P.O. & P.S. Siliguri, Dist-
Darjeeling, would like to inform you the following facts:-

1. That on 22.01.2006, my marriage was solemnized with Swapan Bala Son of
Nikhil Bala, resident of Kawakhali, Bidhan Pally, P.O. Sushrata Nagar, P.S.
Matigara, Dist- Darjeeling, and out of our wedlock relation on daughter namely
Miss Priyanka Bala, aged about 16 years, studying in Class- X, at Siliguri Girls
High School, Siliguri.
2. That soon after marriage my husband Swapan Bala, his mother Smt. Mira Bala,
his sister Swapna Bala (Hazra) started torturing me both physically and
mentally. They used to make me do all their house hold works whole day as
maid servant. All the time my husband and my aforesaid in-laws used to pick-
up quarrel with me and used to tell me to bring dowry from my parents house
and used to tell that I am not beautiful and they are tolerating me for which I
have to bring more dowry from my parents house otherwise my husband would
leave me. I could not fulfill their demand of dowry so their torture upon me
increased rapidly day by day and even my husband in the year 2021 assaulted
me black and blue and even broke my teeth in the said assault.

I, tolerated all their such torture in the hope that one day they would change
their nature and character but all in vain.

3. That several times my husband and in-laws drove me out from my in-laws house and told to come back after bringing dowry from my parents house and after that my mother for the better future used to give something to my in-laws, but they kept on demanding dowry from me and my mother.
4. That my husband and in-laws used to tell me that if I and my mother do not fulfill their demand of dowry then they would marry my husband with another lady and get huge and handsome amount dowry from there.
5. That in a month of March 2023 my husband and my aforesaid in-laws drove me and my minor daughter out from my in-laws house after mercilessly assaulting me.
6. That thereafter salishi meeting was held but my husband flatly denied to leave with me as husband and wife and asked me to give divorce to him.
7. That since after that I have been living in my mother's house at above mentioned address and my husband never came to see us nor he provided single penny for our maintenance.
8. That on 23.8.2023 I came to know my husband has married again with one lady namely Monika Sarkar, D/O. Basona Sarkar of Alipurduar and knowing this I went to my in-laws house for asking about the matter at that time my in-laws i.e. Swapna Hazara (sister in-law), her husband Sanjay Hazra, mother in-law Mira Bala, abusing me in filthy languages and told that my husband has married again as I could not bring dowry as per their demand and even body shamed me and told I am nothing in my in-laws house and if I come again there, then they would murder me.

I, therefore, request to you to kindly take necessary legal action against the aforesaid culprits for the commission of the aforesaid offences by them.
