
With due respect, I am producing herewith 01 (one) arrested accused person namely (i) Deepak Paswan (24) s/o Uday Chand Paswan of Rajaholi, Ward No.-35, PS-New Jalpaiguri, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- (i) 13 (Thirteen) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)
- (ii) One Golden and Red Color beg style as Horse Man.

I, ASI-Khagen Barman presently attached with NJP PS under your kind control beg to state that on 30.08.2023 at 2105 hrs I received a secret source information that one person namely Deepak Paswan (24) s/o Uday Chand Paswan of Rajaholi, Ward No.-35, PS-New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at road side at NJP Kachagali, near Netaji More, under New Jalpaiguri, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 1520 date: 30.08.2023 and informed the fact to you. As per your kind direction and instruction myself along with C/453 Uttam Dey, C/1044 Hari Kherwar, VP/13 Jamirul Islam all of NJP PS, SPC left for NJP Kachagali, PS- New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. At 2125 hrs we arrived at Kachagali as per indication by the source I apprehended one person selling ID liquor at Road Side at Kachagali, On being asked he disclosed his name and address as Deepak Paswan (24) s/o Uday Chand Paswan of Rajaholi, Ward No.-35, PS-New Jalpaiguri, Dist.- Jalpaiguri. During raid the persons who were buying liquor was able to fled away from the spot. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at Kachagali since long for his illegal gain. On search in the bag carrying by him the above noted I/D liquor recovered from the bag. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from the bag carrying by him. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 2125 hrs to 2215 hrs on 30.08.2023..

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Deepak Paswan (24) s/o Uday Chand Paswan of Rajaholi, Ward No.-35, PS-New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
