I, Pradeep Diyal presently attached with NJP PS under your kind control beg to state that on 01.09.2023 at 0005 hrs I received a secret source information that one person namely Mithun Das (39) s/o Lt. Ganesh Das of Bhaktinagar, Pipe Line, PS-NJP, Dist.- Jalpaiguri is selling ID liquor illegally at IOC raod side at NJP Bhaktinagar, Ward No.-35 under New Jalpaiguri, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 02 date: 01.09.2023 and informed the fact to you. As per your kind direction and instruction myself along with C/453 Uttam Dey, C/1044 Hari Kherwar, VP/13 Jamirul Islam all of NJP PS, SPC left for IOC Road, Bhaktinagar, Ward No.-35, PS- New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. At 0015 hrs we arrived at IOC Road, Bhaktinagar, ward No.-35 as per indication by the source I apprehended one person selling ID liquior at his Shop styles as Ganesh Hotel. On being asked he disclosed his name and address as Mithun Das (39) s/o Lt. Ganesh Das of Bhaktinagar, Pipe Line, PS-NJP, Dist.- Jalpaiguri. During raid the persons who were buying liquor was able to fled away from the Shop. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop located at IOC Road, , PS-New Jalpaiguri, Dist.- Jalpaiguri style as Ganesh Hotel. On search in the shop stlyle as Ganesh Hotels above noted I/D liquor recovered. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from the shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 0025 hrs to 0105 hrs on 01.09.2023..

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Mithun Das (39) s/o Lt. Ganesh Das of Bhaktinagar, Pipe Line, PS-NJP, Dist.- Jalpaiguri and arrange for its investigation.
