Accordingly, I diarized the fact in the General diary vide NJP PS GDE No:

date: 01.09.2023 and informed the fact to you. As per your kind direction and instruction myself along with C/453 Uttam Dey, C/1044 Hari Kherwar, VP/13 Jamirul Islam all of NJP PS, SPC left for 10C More, Bhaktinagar, Ward No.-35, PS- New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. At 0755 hrs we arrived at IOC More, Bhaktinagar, ward No.-35 as per indication by the source I apprehended one person selling ID liquior at his Shop. On being asked he disclosed his name and address as Manoranjan Byapari (45) s/o Makhan Byapari of Bhaktinagarm, Jantapara, Ward No.-35, PS-New Jalpaiguri, Dist.- Jalpaiguri. During raid the persons who were buying liquor was able to fled away from the Shop.
