Sir,

With due respect I, Shreya Dural, W/O Kritagya Pradhan, Aged 26 years, R/o Kalimpong 7th mile, P.O. & P.S. Kalimpong, Dist. Kalimpong, would like to lodge a written complaint against:

- 1) **KRITAGYA PRADHAN**, S/O Krishna Kumar Pradhan, aged 29 years,
- 2) **KRISHNA KUMAR PRADHAN**, S/O not known, aged 68 years,
- 3) **MANDIRA @ ANUPAMA PRADHAN**, W/O Krishna Kumar Pradhan,
ALL residence of Gurung Busty Bazaar, Gurung Busty, P.O. & P.S. Pradhan Nagar, and Dist. Darjeeling,
- 4) **ANURAGH PRADHAN**, S/O Krishna Kumar Pradhan, aged 35 years (Assistant Director), R/O Goregaon, East towards Railway Station Mumbai, and Dist. Maharashtra, and
- 5) **ISHA EVA PRADHAN**, W/O Nikkie Dorjee, aged 38 years, R/O Red Rose Hotel, P.O. & P.S. Darjeeling, and Dist. Darjeeling.

That the Above named persons are my husband, father-in-law, mother-in-law, brother-in-law and sister-in-law, respectfully,


That after having one year of relationship we got married on 23rd March, 2023 and we came to the matrimonial home in Gurung Busty where to the shock my in-laws did not accept me as their daughter-in-law as I belonged to the Scheduled Caste. I was beaten up by above named person i.e. no. 2, 3 and 4 so me and my husband started to reside in a rented apartment in Gurung Busty and started a matrimonial life. It was all going fine till 31st May, 2023, when I went to visit my mother at my parental house in Kalimpong. next day I felt sick and on normal check up I found that I have conceived so, I

shared the good news with my husband. My husband was not happy on hearing the news and did not call me the whole day and when I made the call his phone was switched off. Then on 3rd June, 2023, I came to his house in Gurung Busty, his family did not let me inside the house and denied our marriage and baby. I tried to enter in and I was shocked to see my husband inside the house. Later I was physically assaulted by my husband and in-laws. They also abused me saying that "Toh Dural sanu jat ko keti lay mero thulo jaat pradhan ko chora lai fasako, niski hal mero ghar bata ani kosko nani bokeyra mero chora ko mathi jimma halchas". Such inhuman nature and physical assault caused my miscarriage. I cannot define the depth of my sorrow after losing my first child. On 6th June, 2023 I visited Dr. S. Moktan chamber as I was having some health complications. He prescribed me with the medicines and advised me to take rest and then I went back to my parental home but still I was not able to overcome the metal trauma that was caused after losing a child. On 25th June, 2023, my aunty came along with me to convince my in-laws but all went in vain. Thereafter, my husband went hiding with the support of all of above mentioned in-laws and have no where about of him till date. To my bad fortune, my world got destroyed and of such beating I lost my child, my husband also left me and my in-laws did not accept me as their daughter-in-law. Now, I am in the middle of nowhere and feeling hopeless just because I belonged to the Scheduled Caste category.

I would be grateful if your concerned authority would take appropriate action towards my husband and the entire family to provide justice and my unborn baby.
