I my self Anjali Agarwal W/o Bijay Agarwal have been thrown out of the house due to not full fill Demand for Dowry Due to Dowry Mentally Physically Harassment regularly done by Bijay Agarwal Father Mother and when Bijay Agarwal Sister Sister Husband whenever they come to home they also use Slang word and Physically Harassment to keep Regularly Torcher so I could ask my father Mr. Anil Gupta Demand amount should be full fill so it Subjected to continuous Criminal Torture, torment, intimidation and threat of life by my in laws namely Nirmal Agarwal (Father in law), Kusum Agarwal (Mother in law), Rinki Agarwal (Sister in law) and Binod Kumar Agarwal (Brother in Law), these above named person are the main person who has tortured me and also threatened me picking me out of the matrimonial home as I failed to meet their demand of dowry of Rs 10 lakhs, they have driven me and my husband out of the house. My Husband Bijay Agarwal not in favor of their parents so for this region their parents and sister Said to Both of them get out from Home and also told to my husband either get demand amount or give divorce to me, My father is Simple Farmer he cannot full fill my Husband family Demand. They use of vulgar languages and statements like if you dont get the money I will kill you has made my life miserable and my life is at threat due to such actions by my in laws. These causes began immediately after two months of marriage endangering my life.
Currently I don't have Place to survive my life and husband don't have money along with him so I am not getting what to do next and how to tackle will basics daily rutting needs last few days i am Staying in relative home my days and Night are dark so if any things bad happen due to mentally torchers over thinking then My Father in Law, Mother in Law, Sister and Sister husband are responsible for Such a loss. All Four member name Mention Below.
This Four Member is Responsible for all Knownsence work-

2. Kusum Agarwal (Mother in law).
3. Rinki Agarwal (Sister in law).
