In producing herewith one female accused person namely (1) Sonamani Das (F/43yrs) W/O- Manik Das of Gatikachuya, Khutamara, P.S- Sahebganj, Dist- Coochbehar (not verified) in custody and the following property under seizure along with seizure list:-

 One Red & Yellow color Sack containing one plastic wrapped packet containing said to be Ganja weighing approx 7.193 kgs and Marked as exhibit-"A"

ii. One Green color plastic bag containing one plastic wrapped packet containing said to

be Ganja weighing approx 5.162 kgs and Marked as exhibit-"B"

iii. One floral printed lady bag containing one plastic wrapped packet containing said to be Ganja weighing approx 5.156 kgs and Marked as exhibit-"C"

I, SI Rantu Haldar S/O- Monoranjan Haldar of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 06.09.2023 at 13.15 hrs received a secret source information that one lady having possession of huge quantity of Narcotics Substances in her possession without valid documents and standing at Bangla Bazar more, check post to sell the same to her designed customer for her wrong full gain. Accordingly the information was diarized vide BKN PS/SPC GDE No. 284 Dtd. 06.09.2023 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with, ASI Dipak Karmakar, ASI Chandra Prakash Adhikary, LC/1212 Nirita Lama all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No-1666/23 Dt. 06.09.2023 to verify the veracity of information corresponding BKN PS/SPC, GDE.NO. 285 Dated. 06.09.2023. At the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 13.45 hrs on arrival there I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Dulal Das (M/42yrs) S/O- Lt Suresh Das of 2nd mile, Check post, near Parijat School, P.S- Bhaktinagar, Dist- Jalpaiguri M- 9954042963 and (ii) Lalmohan Barman (M/45yrs) S/O- Lt Makhan Ch Barman of Bhupendra nagar, W.No-42, P.S- Bhaktinagar, Dist-Jalpaiguri M-7864022206 also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness. At about 14.05 hrs as per identification by source I managed to detain the said lady. After disclosing our identity, we detained one Lady with strong reason to believe that she is illegally carrying Narcotics Substances for supplying/ selling the same in Siliguri area for his wrongful gain. On being asked she disclosed her identity as noted above and admitted that she possessed Narcotics Substances. Then I asked her whether she wanted to be search in presence of an Executive Magistrate or any Gazetted Officer and she agreed to search by any one. I served her a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and apprehended lady to search our Police Party as per provision. But they refused to search by the police party. Then I asked ASI Dipak Karmakar with a requisition to go to Shri Rajen Kr Chettri ACP DD/SPC office as he was detailed for Special Executive Magistrate. at 14.50 hrs ASI Dipak Karmakar returned with Special Executive Magistrate Shri Rajen Kr Chettri ACP DD/SPC. I disclosed the identity of Shri Rajen Kr Chettri ACP DD/SPC to the

apprehended lady and witnesses as a Special executive magistrate. Thereafter under the supervision Shri Rajen Kr Chettri ACP DD/SPC and in presence of him and independent witnesses I conducted search by LC/1212 Nirita Lama of the above apprehended lady after maintaining all sorts of decency of the apprehended lady, keeping strict regard and found the articles as per seizure list from her possession. On being asked she further confessed in presence of Special executive magistrate and other witnesses that she procured the Narcotics Substances clandestinely for the purpose of selling to her designed Customers in order to earn huge amount of money for her wrongful gain. On interrogation she disclosed that she has been dealing in such illegal drug trafficking business and selling the same to the adjacent area of Siliguri, NJP and Bhaktinagar area. On examination of the alleged apprehended lady noted above regarding any documents for carrying/possessing of said Narcotics Substances she failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Shree Shri Rajen Kr Chettri ACP DD/SPC I seized the articles under proper seizure list and Label under the supervision of Shri Rajen Kr Chettri ACP DD/SPC in presence of witnesses duly signed by them as well as the accused lady and marked the seized exhibits as noted above.

The seizure and label was made between 15.05 hrs to 16.10 hrs. The whole process of search and seizure was video graphed by the videographer namely Netai Chowdhury. Then I arrested the above noted accused lady u/s- 41 Cr.P.C after observing all formalities of arrest and disclosed her cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged person under proper receipt as the alleged accused lady violated the terms and condition of N.D.P.S Act possessing Narcotics Substances without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely 1. Sonamani Das (F/43yrs) W/O- Manik Das of Gatikachuya, Khutamara, P.S- Sahebganj, Dist- Coochbehar (not verified) and arrange for its investigation.
