Sir, today at about 02:15 P.M. when I was near New Paul para, Ward No. 39, P.O. Haider para, P.S. Bhaktinagar Dist - Jalpaiguri at Silsiya Club at that point of time the father of above named lady Sri Manindra Nath Sarkar of Netaji Nagar, Near Ambedkar Club, P.O. Ghogomali, P.S. - Bhaktinagar

Came at the same place and he started to assault me without any reason and cause with a sharp cutting weapon and he attacked on back side of my head and injured me badly and he snatched my sunglasses and headphone and threaten I call my sister over phone and when she reached there the above named Manindra Nath Sarkar also assaulted my sister and outraged her modesty by touching her body in public and hearing the hue and cry the local public gathered at the place and I said Manindra Nath Sarkar left the place, go by threatening us that he will kill me and my entire family whenever he get the opportunity.

Sir, due to the said assault I sustained severe injury on my body and I rushed to Siliguri District Hospital and I was given proper medicines and doctor has opined that my head has sustained grievous injury and he reported 2 stitches on my head.

I therefore request you to kindly lodge a proper case and do all possible works as per law.
