l, ASI Khagen Barmarn of New Jalpaiguri PS, Siliguri Police Commissioenrate do hereby lodge this written compliant againt the unknown mob of Approximately 50-60 to the effect that on 01.09.2023 at 2255 hrs while performing petroling duty under New Jalpaiguri PS, Siliguri Police Commissionrate along with force namely ASI- Dhruba MIshra, C/1044 Hari Kherwar, CV/306 Biswajit Dutta, CV/824 Niru Kumar Jadav I, received an information from duty officer ASI- Binay Subba that one accident took place at Ambikanagar Bazar, under New Jalpaiguri PS, Dist.- Jalpaiguri and unruling mob set the offending vehicle on fire. Accordingly, myself along with force had been to Ambikanagar to verify the varaisity of the information. At 2305 hrs Myself along with force arrived at the Ambikanagar Bazar and found that one Truck bearing Registration No.-WB/73D/1351 dash one scooty bearing registration No.WB/AW/5538 consequently the rider of the scooty died on the spot. Accordingly the leaderless unknown mob of Approximately 50-60 vandalised the offending vehicle bearing registration No.-WB/73D/1351 and set the Truck on fire by unknown unruling mob. Accordingly, I informed the matter to Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate and informed about the situation and requested him to accomplained us with more officer and force. Accordingly, as per order of Officer-In-Charge, New Jalpaiguri PS, Siliguri POlcie Commissionerate both the RT van officer namely SI-Dipankar Chakraborty and ASI Manoj Majumdar along with force who are detailed to perform Van duty under New Jalpaiguri PS, Siliguri Police Commissioenrate vide New Jalpaiguri PS MCC No.-1490/23 dated: 01.09.2023 arrived at the spot and we tried to resist the unruling mob to maintain law and Order situation and advise Mob of approxmitly 50-60 to go home but the runruling mob all are in vain and they refused to obey our order, instead they pelted stone againt the Police Team on duty and create hindrance to discharge Public service. Several endeavour has been made to prevent the detaoriting the Law and Order situation and finding no other alternative, when we approach them to arrest, all the unruling mob fled away form the spot.

Under this fact and circumstances, I, therefore pray before your kind honour that a specific case may kind be registered under proper section of law agasint unknown person and Mob of Approx 50-60 People and arrage for its investigation.
