I Rahul Ray S/o Ram Shovit Ray R/o Bhanu Bhakta Sarhani, Pradannager, M.Corp, P.O:- Champasari, P.S:- Pradhannager, District:- Darjeeling, Pin:- 734003.

That I would like to inform you that I with my friends went to "Just One More Pub" on 05/09/23, there I met my old friend Deepak Choudhary as we met after a long time we were spending some good quality time. Then suddenly the abovenamed accused Shubham the staff/bouncer of that Pub suddenly came and hit me on my face with tight fist and slap after that I was in utter shock and was not in condition to save myself from the abovenamed accused, me with my friend left the Pub after duly paying the bill. Then the above named accused Nikhil and Shubham with Manish made me a call stating that they are sorry for whatever happened in the pub but later did I know it was just a way to call me in odd hours to hit me again, and believing them and to clear the confusion and to end the quarrel, I went to meet them but as soon as I reached there at Champasari Anchal with my friend without wasting a single minute Manish and the abovenamed accused Nikhil Prasad and Shubham started hitting me and they showed Rambo Knife (Sharp Knife) and threatened to kill me. To save myself from them I tried to run from the place but Manish suddenly hit me with an empty beer bottle from back in my head with a pure intention to kill me and then I was senseless and my friend namely Robin Mida to save myself reached the spot and in the mere time he also suffered severe injury in his hand and got seven stiches in his left hand but somehow he manage to rescue me from the abovenamed accused persons had he not been present in the spot to save me I would be killed by the abovenamed accused person and he took me to the Siliguri Hospital for the treatment and I woke up in the morning with immense pain in my head.

I request you kindly to take strict action against the miscreants and save me from them as I am continuously getting death threats from them and if the action is not taken as soon as possible me along with my family life is at risk from the abovenamed accused person.
