Sir,

In producing herewith one arrested accused person named Pyarelal Sha (40) S/O Basudev Sha of Jhauguri, PO-New Chumta, PS-Matigara, Dist-Darjeeling along with following articles under proper seizure list.

(i) 03 (Twelve) bottles of 'Himalayan Gold 60 UP' Country Spirit India Made Liquor containing 500 ml in each bottle and value of Rs 155/- of each bottle and marked as 'Exhibit -A' out of which 01 (One) bottle has been taken as sample for examination and marked as "Exhibit A-1".

(ii) 18 (Eighteen) bottles of KACHI 70 UP India Made Liquor each bottle containing 300 ml and value of Rs. 40/- of each bottle manufactured by Prakash Distillery & Chemical Co. (P) Ltd. and marked as "Exhibit-B" out of which 01 (One) bottle has been taken as sample for examination and marked as "Exhibit B-1"

I, ASI Pema Dorjee Sherpa of Matigara Police Station under Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted arrested accused person namely Pyarelal Sha (40) S/O Basudev Sha of Jhauguri, PO-New Chumta, PS-Matigara, Dist-Darjeeling to the effect that on 08/09/2023 at 19:05 hrs I received a source information that one person namely Pyarelal Sha of Jhauguri, PO-New Chumta, PS-Matigara, Dist-Darjeeling is selling illegal liquor at his residence without any valid license. Accordingly the fact was diarized in General Diary vide Matigara PS GDE No 424 dated 08/09/2023 and shared the information with O/C Matigara PS and as per his kind order and direction I along with force had been to the house of the above noted accused person to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the house of accused Pyarelal Sha and managed to apprehend him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. On searched the above noted seized articles were recovered from the house of the said accused Pyarelal Sha. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labelled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Pyarelal Sha after observing all sorts of formalities at the spot informing him the ground of arrest. The whole process of seizure and label has been made on 08/09/22 in between 19:40 hrs to 19:55 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused person Pyarelal Sha (40) S/O Basudev Sha of Jhauguri, PO-New Chumta, PS-Matigara, Dist-Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
