Darjeeling, would like to draw your kind attention in that effect that I am a registered Land-Clerk of Siliguri Court and has been practicing as a Land-Clerk at Siliguri Court from the year 2005 vide registration no. 23/2005.

That on 10/9/23, i.e. yesterday at about 12:00 to 12:15 am (night), when I going towards my home from my work, at that time one police personnel namely Sri. Samir Mauna (works under Siliguri Police Commissionerate) suddenly stopped me near Khalpara, Siliguri and started asking for money and at that time he was heavily in drunken condition and thereafter when I refused to give him money, at that time said Samir Mauna started abusing me with filthy languages and thereafter when I requested him to stop abusing me, said Samir Mauna started to beat me mercilessly and as a result I got severe serious injury in my head, face and also in my chest. Thereafter finding no other alternatives, when I started to shout as 'Baahao Baahao', at that time said Samir Mauna threatened me that he will kill me if I don't give him money and also snatched my Gold Chain from my neck and also Rs. 15,500/- from my money bag/purse.

Thereafter after hearing my hue and cry, some Para people came at this spot to rescue me from his clutch but said police personnel became more furious towards me and the Para people and after some time when my wife and mother came to know about this incident they hurried to the spot to rescue me and also requested said Samir Maama to free me but said Samir Maama did not hear them and also started beat my mother and wife and tried to disrobe my wife by forcing her wearing apperals.

Thereafter the others Para people rescued me and my family members from the clutch of said Samir Maama and with the help of Para people I went to the spot Siliguri District Hospital for treatment and after seeing my injury, doctor suggest me to do C.T. Scan of my head and thereafter the local Para people reached me to my home.

Sir, I requested you to please look into this matter and take appropriate necessary legal action against said Samir Maama for the interest of justice.
