Respected Sir,

I Anish Kumar Prasad S/o – Binod Prasad Sah resident of Gurung Basti main road near Tea Time café, Ward no – 03, PO & PS – Pradhan Nagar, Siliguri, Dist – Darjeeling beg to state as follows:-

That on 05/09/2023 my younger brothers namely Manish Prasad & Nikhil Prasad went to a club named "Just One More Pub" for having their dinner and there they met a person named Rahul Ray S/o Ram Shovit Ray resident of Bhanu Bhakta Sarani, Pradhan Nagar, Siliguri, dist - Darjeeling (Mob - 9064424562) & his friend Md. Jabbar resident of Near Ram Narayan Ground, Gurung Basti, Siliguri (Mob- 7908580589) they were highly intoxicated in the Club after sometime both of them started abusing my younger brothers & used filthy languages with my younger brothers without any reason and started quarrelling with them then the Club Management & Bouncer named Subham of the said Club interfered and somehow rescued my brothers, Then Rahul Ray & Md. Jabbar left the Club around 12:30 am without clearing their total bill. Then they have directly visited my House Locality and started giving death threats to my Younger brother's again & again due to fear my brothers were not returning to our house. During that period of time the abovenamed persons were continuously drinking alcohol outside our house and they were waiting for my younger brother's to return back home so that they can satisfy their ego, After waiting till 1:30 am due to fear my younger brother's decided to return back to home as it was very late at night, While returning from the said club my younger brother's suddenly met Rahul Ray & Md. Jabbar coincidentally near Champasari More my younger brother's requested them to please leave them alone as they don't want to engage in any kind of violence but the abovenamed person's directly started hitting them with fist and blows & they were brutally slapping my younger brother's and not letting them to come back to their home, After the torture of almost 1 hour my younger brother's some how managed to escape from there and reach their home.

From the very next day morning my younger brother's started getting threat calls from various unknown numbers, they threatened us by saying that they will burn my younger brother's face with acid if they see them in the locality or anywhere ,we know name of two threat callers Md. Bittu Hussain & Bikky Ray (Brother of Rahul Ray) , they even said that they will cut my younger brother's into pieces. Sir ,Md. Jabbar is a habitual offender & Rahul Ray S/o Ram Shovit Ray is his partner in various crimes and from source of information I got to know that both Md. Jabbar & Rahul Ray are Drug Peddlers and multiple number of cases against them are pending in the Various Courts.

That the above named persons also demanded Rs 2 Lakhs without any reason and asked me, that if we do not give them Rs 2 Lakhs then they shall kill my Younger brother's, That the above named accused persons are notorious Criminals in the Society. That indirectly they claiming Extortion Money.

Therefore it is my earnest request to the police department to take the necessary legal action against the accused persons and save my Younger brother's life, I have all Video Footage & Photos available as well as threat call recordings and shall produce any time if necessary.
