Respected Sir,

I, Sri Chewang Damdu Lama (Bhutia), Son of Late Tamding Norbu Lama (Bhutia), permanent resident of Beech Wood Nook, 7, Laden La Road, P.O., P.S., and Dist. – Darjeeling, would like to lodge this Complaint with you that I along with my brother viz. Sri Nima Tshering Lama (Bhutia) (now deceased) and my sister, Smt. Sonam Doma Bhutia are the joint owners-in-possession of a land measuring 0.35 Acre, recorded in L.R. Khatian Nos. – 204 and 205 under Plot No. – 223, at Mouza – Chamta, P.S. – Matigara, Dist. – Darjeeling.

My Sister, Smt. Sonam Doma Bhutia is also the registered owner of a land measuring 0.33 Acre, recorded in Khatian No. – 206, under Plot No. – 223, at Mouza – Chamta, P.S. – Matigara, Dist. – Darjeeling.

My brother, Sri Nima Tshering Lama (now deceased) is also the recorded owner of land measuring 0.33 Acre, recorded in Khatian No. – 808, under Plot No. – 223, at Mouza – Chamta, P.S. – Matigara, Dist. – Darjeeling.

Sir, myself with my brother and sister have constructed one temporary structure, by covering our aforesaid land with pucca brick boundary wall and also affixing one Iron Gate thereon, in the year 2011, one Banu Munda and Kamal Munda have illegally tried to capture our said land and thus, we have filed three separate suit before the Ld. Civil Judge (Jr. Division) at Siliguri being Title Suit Nos.- 79/2011, 80/2011 and 81/2011 and after hearing all the sides, lastly on 08.01.2014, the Ld. Civil Judge (Junior Division) at Siliguri was pleased to pass an order of injunction by restraining the Defendants from entering into the suit property and also restrained them from disturbing our peaceful possession till disposal of the suit in respect of Title Suit Nos.- 79/2011 and 80/2011 and thereafter, the same order has been passed by the Ld. Civil Judge (Junior Division) at Siliguri on 27.03.2014 in respect of title Suit No.- 81/2011 and the aforesaid permanent injunction is still now subsisting in respect of the aforesaid land.

Sir, subsequently, the Ld. Civil Judge (Junior Division) at Siliguri was also pleased to passed an direction upon the O.C., Matigara Police Station to see that the injunction order of the Ld. Court should not be violated in respect of the aforesaid three civil suits.

Sir, instead of having knowledge of the aforesaid permanent and absolute injunction, on 11.09.2023, in the afternoon, with the instigation of Nirjhar Rasailly (Mobile- 8945820840), Son of N.B. Rasailly, resident of Church Road, Salbari, Banu Munda and Kamal Munda alongwith some persons viz. Smt. Panna Sherpa, Smt. Anju Tamang, Phupu Chedar Bhutia, Gayas Pega Limbu,

Som Darjee (Tamang), Sharan Tamang, Roshan Tamang, Lakpa Bhutia, Ugen Tamang, Swapan Tamang, Dhiren Tamang, and Sujita Subba, have illegally broken the iron gate and some portion of boundary wall illegally and they have forcibly trespassed into our land and completely ultraviolating and disobeying the order of injunction most illegally started digging in the earth and started construction for their and illegal gain.

I, therefore, humbly praying with you to look into this matter and also to take immediate drastic legal actions against Nirjhar Rasailly (Mobile- 8945820840), Son of N.B. Rasailly, resident of Church Road, Salbari, Banu Munda and Kamal Munda, some persons viz. Smt. Panna Sherpa, Smt. Anju Tamang, Phupu Chedar Bhutia, Gayas Pega Limbu, Som Darjee (Tamang), Sharan Tamang, Roshan Tamang, Lakpa Bhutia, Ugen Tamang, Swapan Tamang, Dhiren Tamang, and Sujita Subba, in accordance with law. Your good office and urgent co-operation is very much expected in this regard.
