In producing herewith three arrested accused persons namely (1) Rahul Das @ Sarkar-20yrs s/o Chaityanno Sarkar of Durganagar, Near Kali Mandir, ward No-40, PS Bhaktinagar Dist Jalpaiguri (2) Monoj Roy @ Dipankar -26yrs s/o Tapan Roy of Amtala, Sastrinagar Ward No-41PS Bhaktinagar Dist Jalpaiguri and (3) Rahul Tamang-34yrs s/o Lt Ramvir Tamang of Baikunthapally, Near Bottle company, Ward No-41, PS Bhaktinagar, Dist Jalpaiguri along with seized articles;

I, PSI Chiranjit Saha s/o Madhab Saha of Bhaktinagar Police station do hereby lodge the complaint that today on 12.09.23 at 14.05 hrs received source information that since some days one Rahul Das and others are ruining on line lottery at his rented shop at Bottle company bazar, ward no-41 with money for their wrongful gain and wrongful loss and may be apprehended with such lottery if responded immediately. Accordingly, the matter was diarised in General Dairy vide Bhaktinagar PS GDE No-592 dated 12.09.23 and informing your end, without making any delay, I along with SI Srimanta Chatterjee, SI Mrinal Basunia, SI Rantu Halder, Const/374 Debraj Biswas, const/1426 Prasanta Kumar Dutta in mufti rushed to the spot. This refers to Bhaktinagar PS GD entry no 593 dated 12.09.23.

On way requested two disinterested persons namely (i) Narajit Roy s/o Lt Tiken Roy of Roy colony Chayanpara, PS Bhaktinagar Dist Jalpaiguri and (2) Nimai Sarkar s/o Sunil Sarkar of Amtala Sastrinagar ward no-41 PS Bhaktinagar Dist Jalpaiguri to stand as a witness to the search and seizure if any.

At 14.25 hrs reached the place of occurrence, contacted with the source and as pointed by the source cordoned the shop of Rahul Das. On entering shop in presence of the witnesses apprehended three male persons noted above and disclosed our identity as police personnel. At then, said persons started trembling in panic. On being asked the persons disclosed their identity as noted above. Then disclosing our presence and following all formalities conducted search of the shop. In the shop the above noted arrested persons seating on the chair on which the computer was operating. In the shop the above noted articles could be recovered.

On being asked said Rahul Das and others stated that they ruining this business of online gambling under the leadership of one Biswajit Mondal of Malda, and Prem

Sharma of Durganagar under Bhaktinagar PS who was fled away from the spot. Further they also could not produce any valid papers/License/documents in support of such possession of recovered articles on which are used in on line lottery in exchange of money with playing through internet with a view to wrongful gain and wrongful loss. They are cheated the general public to invest their money on that lottery.

Accordingly, I prepared seizure list and seized the above noted articles, duly signed by the witnesses and acknowledge by the accused persons and arrested the accused (1) Rahul Das @ Sarkar-20yrs s/o Chaityanno Sarkar of Durganagar, Near Kali Mandir, ward No-40, PS Bhaktinagar Dist Jalpaiguri (2) Monoj Roy @ Dipankar -26yrs s/o Tapan Roy of Amtala, Sastrinagar Ward No-41, PS Bhaktinagar Dist Jalpaiguri and (3) Rahul Tamang-34yrs s/o Lt Ramvir Tamang of Baikunthapally, Near Bottle company, Ward No-41, PS Bhaktinagar, Dist Jalpaiguri u/s 41 CrPC (Seizure time 14.55hrs to 15.50hrs).

Under the above, I pray before your kind end to start a case against the above arrested persons (1) Rahul Das @ Sarkar-20yrs s/o Chaityanno Sarkar of Durganagar, Near Kali Mandir, ward No-40, PS Bhaktinagar Dist Jalpaiguri (2) Monoj Roy @ Dipankar 26yrs s/o Tapan Roy of Amtala, Sastrinagar Ward No-41, PS Bhaktinagar Dist Jalpaiguri and (3) Rahul Tamang-34yrs s/o Lt Ramvir Tamang of Baikunthapally, Near Bottle company, Ward No-41, PS Bhaktinagar, Dist Jalpaiguri also one Biswajit Mondal of Malda and Prem Sharma of Durganagar PS Bhaktinagar Dist Jalpaiguri under proper section of law and caused its investigation.
