I Ajit Biswakarma, S/O Arjun Biswakarma
Resident of Salugara, ward No: 42 (SMC) Siliguni, P.O Salugara
P.S Bhaktinagar Dist. Jalpaiguri, would like to Inform
you, That Amrita Biswakarma, daughter of Arjun Biswakar
-ma, is my sister and she was found dead (By
hanging) dated 10/09/23 at morning around 4:30 AM
at our residence. That as soon as we come to know
about the matter we informed the Bhaktinagar
Police station about the matter, and the body
was taken for postmortem by the Police at
North Bengal Medical collage. Then after Post-mortem
the body was handover to us, and we burnt the
body following our hindu rituals.


That now from different sources we come to know
that my sister Amrita Biswakarma was mentally
torture, pressure and forced to commit
suicide by a person name, Raj Das, S/O Apu
Das, resident of Dagapur, Vandelijote, Near, jubog
songa club Siliguni, (Mobile - 7063589793),
That Raj Das mentally torture and blackmailed
my sister and Insulting to which she committed
suicide.

I therefore request you, who with my hands kindly took into the matter and take legal action againsts Raj Das.
