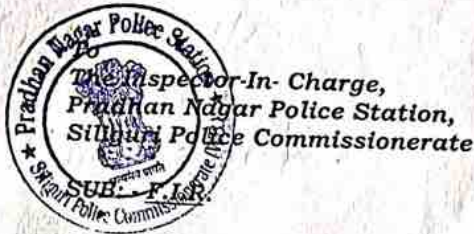

In producing herewith one accused person named Raju Rai(48Y/M), S/O. Lt. Maila Roy of Siliguri Junction, Ps. Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

Fifteen (15) bottles of HIMALAYAN GOLD 60 UP COUNTRY SPIRIT, each bottle containing 600 ml, each bottle MRP-155 rupees (Total 9 litre), marked as exhibit A (Out of which one has been taken as sample for examination marked as exhibit A1)

I, ASI Manoj Kr. Roy of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Raju Rai(48Y/M), S/O. Lt. Maila Roy of Siliguri Junction, Ps. Pradhannagar, Dist. Darjeeling to the effect that today on 12.09.2023 at 22.00 hrs received a source information that one person has been selling huge illegal liquor at Vancha Ghar hotel, Siliguri Junction under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with CV/646. Baban Das and CV/992 Jagadish Biswas (All of Pradhannagar Ps) had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of source information vide Pradhannagar ps GDE no. 765, Dt. 12.09.23. On reaching there and as identified by the source found that above noted person has been selling illegal liquor from Vancha Ghar Hotel at Siliguri Junction. Subsequently, I along with my force able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted seized articles were found in a cartoon. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 01 (ONE) year for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Raju Rai(48Y/M), S/O. Lt. Maila Roy of Siliguri Junction, Ps. Pradhannagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 22.20 hrs to 22.35 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Raju Rai(48Y/M), S/O. Lt. Maila Roy of Siliguri Junction, Ps. Pradhannagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
