Sir,
I Md. Alamgir S/o - Md. Atabul resident
of Tipiapara, Majdoor Colony would like to lodge
a written complaint against Sangira Khatoon,
Nazima Khatoon, Julie Khatoon, Nemat Khatoon as
I have been subjected to utmost physical torture
and mental cruelty by my wife SANGIRA
KHATOON and my daughter NASMA KHATOON who
have not been residing with me since last
6 months as I have been disposed from my
own house and I have been residing with
my married sister at Tipiapara. It is pertinent
to mention that whenever I try to enter my

house all the people named in this Complaint gets violent and start assaulting me physically.

It is painful to mention that in the month of May, 2023 I have been implicated in a false case by my wife by alleging that I along with my other family members tried to assault her in which I have been granted bail as there was no merit in this case.

Since last 2-3 days I have been subjected to utmost cruelty and have been threatened by my wife that if I enter inside my house then she will implicate in a false case of domestic violence as she has strong hold in Tikispara area. When I objected for the same and tried to enter inside the house my wife assaulted me with knife, I fell on the floor then my wife and my daughter started beating me mercilessly.

It is also important to mention that

My wife has kept many members from her family to my house. My sister in law's daughter named JULIE KHATOON has assaulted me with 'BATON' from behind.

That due to the above mentioned assault by them I have sustained grievous injury on my chest, my thighs and deep cut on my finger which has been bleeding profusely. I visited civil hospital and got myself treated by the doctor and I have been suffering from various complications.

Therefore, I request you to look into this matter seriously and take necessary action against the deep rooted conspiracy which resulted in today's assault and which may also be more dangerous in near future.
