Sir,

In producing herewith one arrested accused person namely Rupan Saha (28), S/O - Gopal Saha, of - Thiknikata, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling along with original seized list and seized articles i.e (i) One Green colour Hero brand bicycle and other relevant papers.

The fact of the case in brief is that I, ASI Dulal Dey of North Bengal Medical College & Hospital OP under Matigara PS SPC do hereby lodge a written complaint against the above noted accused person named Rupan Saha (28), S/O - Gopal Saha, of - Thiknikata, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling to the effect that today on 13/09/2023 I along with C/327 Brakat Ali Ahmed and C/131 Kanuram Sarkar of NBMC OP were performing evening mobile van duty vide MCC No- 1135/23 dated 13/09/23 and NBMC OP GDE No- 324 dated 13/09/2023. During my evening mobile van duty at 20:45 hrs I received secret source information that, one person are waiting at Kamal Jote near Water Tank with one stolen Bicycle for sale the same for his illegal gain. Accordingly I informed the information to OC NBMC OP over telephone and as per his direction I along with C/327 Brakat Ali Ahmed and C/131 Kanuram Sarkar of NBMC OP left for PO to workout the information. On arrival at Kalam Jote near Water Tank at 20:55 hrs being pointed out by the source, we apprehended one person as mentioned above and recovered 01 (one) of Hero brand bicycle from his possession. On demand they failed to produce any documents in support of said Bicycle. On further interrogation he confessed that, few days ago he stolen the above mentioned Bicycle from Thiknikata area and today he came here for sale the same for his illegal gain.

Accordingly I seized the said bicycle i.e (i) One Green colour Hero brand bicycle under proper seizure list. The seizure was made in between 21:05 hrs to 21:15 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him.

Under the above circumstances I am submitting this written complaint against the above noted accused person namely Rupan Saha (28), S/O - Gopal Saha, of - Thiknikata, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling for starting a specific case under proper section of law and to arrange for its investigation.
