Kalimpong, (ii) Arbin Pradhan (25 yrs) S/O Gobin Pradhan of Starling, Ghoom, PS- Jorebanglow, Dist.- Darjeeling, (iii) Shiba Chhetri (21 yrs) S/O late Suresh Chhetri of Sourini Bazar, PS- Mirik, Dist.- Darjeeling and (iv) Ujjal Chhetri (33 yrs) S/O Uday Chhetri of Thakurigaon, Pokhrebong, PS- Sukhia Pokhri, Dist.- Darjeeling along with following seized articles viz:-

- (1) One iron made sharp cutting weapon called as 'Bhojali' recovered from the exclusive possession of accused Md Firoz @ Raj.
- (2) One iron made 'Knife' and one torch light recovered from the exclusive possession of accused Arbin Pradhan.
- (3) One iron made weapon called as 'Bhojali' recovered from the exclusive possession of accused Shiba Chhetri.
- (4) One 'iron rod' measuring approximately 3 feet in length and one sharp cutting knife recovered from the exclusive possession of accused Ujjal Chhetri.

I, SI Goutam Mallik of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 04 (four) arrested accused persons namely (i) Md Firoz @ Raj (27 yrs) S/O Md Ainul of 8 th Mile, PO+PS+Dist. Kalimpong, (ii) Arbin Pradhan (25 yrs) S/O Gobin Pradhan of Starling, Ghoom, PS- Jorebanglow, Dist.- Darjeeling, (iii) Shiba Chhetri (21 yrs) S/O late Suresh Chhetri of Sourini Bazar, PS- Mirik, Dist.- Darjeeling and (iv) Ujjal Chhetri (33 yrs) S/O Uday Chhetri of Thakurigaon, Pokhrebong, PS- Sukhia Pokhri, Dist.- Darjeeling and others to the effect that today on 14/09/2023 at 00:45 hrs received a specific source information that 10/12 youths have assembled at below Mahananda Bridge, Ward No 01 under ps- Pradhan nagar, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Gurung Busty area. Accordinghly, I informed the matter to the I/C, Pradhan Nagar PS and diarised the fact in General diary vide MPradhan Nagar PS GDE No 839 dated 14.09.23 and as per order myself along with ASI Biplob Kumar Das, ASI Monoj Kr Roy, C/762 Mojibul Rahaman, CV/645 Pankaj Gupta, CV/223 Swapan Chhetri and CV/128 Ajoy Kumar Sahani all of Pradhan Nagar PS, SPC, left for Below Mahananda Bridge to work out the information in hand. At about 01:15 hrs we arrived at near Mahananda Bridge and as indicated by the source we noticed that 10/12 persons assembled in a dark place below Mahananda Bridge and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 04 (four) of them with deadly weapons in their possession but 07/08 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. they disclosed that they along with their associates were assembled there and making preparation for committing dacoity in a house of Gurung Busty area. On search the above noted weapon of offence recovered from their possession.
