With due respect and producing herewith 03 (three) arrested accused persons namely (1) Ganesh Kumar (30) s/o Sri Ram Briksh Roy of Rambhaddarpur, PO-Ratwara, PS- Kalayanpur, Dist.- Samastipur, Bihar-847301 (ii) Rahul Kumar Roy (32) s/o Ramkrishna Roy of Pakri, PO-Janardhanpur, PS-Kalyanpur, Dist.- Samastipur, Bihar-848302 (iii) Ranjit Kumar (31) s/o Bindeswar Roy of Gobarsittha, PO- Gobarsittha, PS-Kalayanpur, Dist.- Samastipur, Bihar under arrest and the following articles under seizure. The ground of arrest duly been communicated by them. :-

1. One white Color Scorpio bearing registration No.- BR/22PA/2265 having Engine No.- SJF-4D21645- and Chesis No.- MAITA2SJXF2D31021.

I, ASI Khagen Barman of NJP PS, Siliguri Police Commissionerate beg to report that on 08.09.2023 at 1435 hrs I received an information that one stolen vehicle displaying number plate BR/22PA/2265 is coming from Siliguri Side and with stolen Vehicle to deliver the same to the design customer at Nougkhat under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly I informed the fact to the Officer-In-Charge, NJP PS and diarized the fact in General diary vide NJP PS GDE No. 371 dtd. 08.09.2023. Accordingly as per your kind order myself along with ASI Dhruva Mishra, C/453 Uttam Dey, VP/13 Jamirul Islam, all of NJP PS left for Nougkhat to work out the information in hand. At about 1455 hrs we arrived at Nougkhat and started checking vehicles coming from Siliguri side and finally at about 1535 hrs we noticed that one white color Scorpio bearing registration No.- BR/22PA/2265 is coming from Siliguri Side. We give several signal to stop the vehicle but the said vehicle did not stopped there and left for Jalpaiguri side in high speed violating our signal. After a hot chase at about 1555 hrs we managed to stopped the said vehicle at near Nougkhat but driver and other 02/03 persons started to flee away from the spot. But we the police party after hot chase able to apprehended them. During interrogation they disclosed their identity as noted above. On demand they failed to produce any documents in respect of the said vehicle. After thorough interrogation they admitted their guilt and disclosed that they have stolen the said vehicle and come to Nougkhat under New Jalpaiguri PS, Dist.- Jalpaiguri to the design customer for sale the vehicle for their wroingful gain. There was suffiecient reason to belive that the vehicle is stolen one. Accordingly, I seized the said vehicle under proper seizure list and arrested the above noted three accused persons under proper memo of arrest and observing all the formalities of arrest and brought to NJP PS. There search scaizure was made in between 1625 hrs to 1705 hrs on 08.09.2023.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of law may kindly be initiated against the accused persons namely (1) Ganesh Kumar (30) s/o Sri Ram Briksh Roy of Rambhaddarpur, PO-Ratwara, PS- Kalayanpur, Dist.- Samastipur, Bihar-847301 (ii) Rahul Kumar Roy (32) s/o Ramkrishna Roy of Pakri, PO-Janardhanpur, PS-Kalyanpur, Dist.- Samastipur, Bihar-848302 (iii) Ranjit Kumar (31) s/o Bindeswar Roy of Gobarsittha, PO- Gobarsittha, PS-Kalayanpur, Dist.- Samastipur, Bihar and others and arrange for its investigation.
