Sir,

In producing herewith two arrested accused person named (i) Rajeev Ranjan (31Y/M),S/O. Kameshwar Prasad and (ii) Niraj Kumar(20Y/M), S/O. Raj Kumar both of Phulparas near Refral Hospital, Po+Ps. Phulparas, Dist. Madhubani, Bihar under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

Twenty Four (24) bottles of KINGFISHER PREMIUM LAGER BEER, each bottle containing 330 ml, each bottle MRP-61 rupees (Total 7.92 litr). marked as exhibit A (Out of which one bottle has been taken as sample for examination marked as exhibit A1)

I, ASI Manoj Kr. Roy of Pradhan Police Station, SPC would like to lodge this written complaint against two accused person named (i) Rajeev Ranjan (31Y/M),S/O. Kameshwar Prasad and (ii) Niraj Kumar(20Y/M), S/O. Raj Kumar both of Phulparas near Refral Hospital, Po+Ps. Phulparas, Dist. Madhubani, Bihar to the effect that today on 14.09.2023 at 16.15 hrs received a source information that two person has been carrying illegal liquor at Siliguri Junction under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and diarised the matter in General Diary vide Pradhan Nagar PS GDE No 875 dated 14.09.23 and as per his kind direction mylself along with CV/128 Ajay Kr. Sahani, CV/223 Swapan Chettri (All of Pradhannagar Ps) had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that above noted two person has been carrying illegal liquor. Subsequently, I along with my force able to detain the above noted persons. On being asked the apprehended two person disclosed their name and identity as noted above. Further being searched the above noted seized articles were recovered from their joint possession which were kept with a cartoon. On demand they failed to produce any valid license/papers for selling and storing of such articles. On further interrogation they stated that they are involved in selling and possessing of liquor without any valid license since long for their illegal gain. Accordingly, I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named (i) Rajeev Ranjan (31Y/M),S/O. Kameshwar Prasad and (ii) Niraj Kumar(20Y/M), S/O. Raj Kumar both of Phulparas near Refral Hospital, Po+Ps. Phulparas, Dist. Madhubani, Bihar after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 18.20 hrs to 18.55 hrs at the spot and arrested them after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against (i) Rajeev Ranjan (31Y/M),S/O. Kameshwar Prasad and (ii) Niraj Kumar(20Y/M), S/O. Raj Kumar both of Phulparas near Refral Hospital, Po+Ps. Phulparas, Dist. Madhubani, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
