In producing herewith one seized vehicles tractor along with trolley bearing registration no WB 73 G 4062 partially loaded with river bed materials (Sand). I ASI Amal Roy of NBMC OP Under Matigara PS beg to lodge a written complaint against the driver & owner of the above mentioned vehicle, to the effect that today i.e 14.09.2023 in course of night mobile van duty vide NBMC OP GDE No 334 dated 13.09.2023 I along with C/1085 Mithun Debnath & CV 638 Partha Biswas reached at Selim Ghat of Balason river under Matigara PS and found that some persons were loading river bed materials in a tractor along with trolley the tractor have in the middle of the rivers, seeing the police van driver of the tractor are fled away from the spot. There is sufficient reason to believe that the above noted tractor driver & owner have stolen river bed materials from the river of Balason at Selim Ghat for selling clandestinely. Accordingly, I seized above noted tractor along with trolley bearing registration no WB 73 G 4062 partially loaded with river bed materials (Sand) under proper seizure list. The search, seizure was made in between 00.20 hrs to 00.40 hr on 14.09.2023.

Under the fact and circumstances I pray before you a specific case against the driver & owner of above noted vehicle may kindly be started and arrange for its investigation
