Sir,

In producing herewith one accused person named Dewasish Das (32) S/O Santosh Das of Siliguri Junction PS Pradhan nagar Dist Darjeeling under arrest along with following articles under proper seizure :

Twenty four (24) bottles of Kingfisher strong beer each containing 650 ml, MRP 135/ (Total 15.6 litres),

I, SI Youel lepcha S/O Jai Tshering lepcha of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Dewasish Das (32) S/O Santosh Das of Siliguri Junction PS Pradhan nagar Dist Darjeeling to the effect that today on 15.09.2023 at 13.10hrs received a source information that one person is possessing liquor at Siliguri Junction under Pradhannagar Ps. without any valid license. Accordingly I informed the matter to you and as per your kind direction I along with CV 645 Pankaj Gupta, CV 128 Ajay Kumar Sahani and CV 223 Swapan Chettri all of Pradhan Nagar PS had been to spot to verify the veracity of the information. This refers to Pradhan Nagar P.S. GDE No.917, Dt. 15.09.2023 on reaching there and as identified by the source found that one person was possessing liquor with any valid licence.

Subsequently, I along with my force detain the above noted person. Thereafter on being asked the apprehended person disclosed his name and identity as noted above and stated that he is involved in this business since long. Further being searched the above noted articles have been recovered from his possession. On demand he failed to produce any valid license/papers for possessing liquors. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then I seized and labelled the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Dewasish Das (32) S/O Santosh Das of Siliguri Junction PS Pradhan nagar Dist Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 13.45 hrs to 14.15 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Dewasish Das (32) S/O Santosh Das of Siliguri Junction PS Pradhan nagar Dist Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
