Sir,

In producing herewith two accused persons namely (1) Somnath Roy @ Hodol-30yrs s/o Lt Ananda Roy of Vidyachakro colony, ward No-44, P.S- Bhaktinagar, Dist- Jalpaiguri and (2) Balai Roy-34yrs s/o Lt Ananda Roy of Vidyachakro colony, ward No-44, P.S- Bhaktinagar, Dist- Jalpaiguri in custody and the following property under seizure along with seizure list:-

- i. 26 (Twenty six) pieces of LUPIGESIC injection composition with Buprenarphine Hydrochloride IP equivalent to Buprenarphine 0.3mg each vials containing 02 ML (Total-52ML) and marked as Exhibit-A
- ii. 26 (Twenty six) pieces of PHENERGAN injection which composition with Hydrochloride IP, 25mg, each vials containing 02 ML (Total-52ML) and marked as Exhibit-B
- iii. 26 (Twenty six) pieces of DIAZEPAM injection composition with Diazepam 1P 5mg each vials containing 02 ML (Total-52ML) and marked as Exhibit-C
- iv. 21 (Twenty one) Bottles of ALTORAX-CD Cough Syrup each bottle containing with Codeine phosphate & Chlorpheniramine Maleate syrup, each bottle containing 100ML. Codeine phosphate 1P 10mg (100 MLx21 = 2100 ML (02 Ltr) and Marked as exhibit-"D"
- v. One Royal Enfield motor cycle having Registration No-WB74BQ/8508
- vi. One Samsung mobile phone having IMEI No-352231/10/092924/4
- vii. One yellow colour bag, Pooja HINDUSTAN written in outside of the bag.

I, PSI Chiranjit Saha s/o Madhab Saha of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 15.09.2023 at 19.25 hrs received a secret source information that two persons including having possession of huge quantity of Narcotics Substances in their possession without valid documents and selling to the addicted young boys at NH-31 area through one Royal Enfield motor cycle under PS- Bhaktinagar. Accordingly the information was diarized vide BKN PS/SPC GDE No. 770 Dtd. 15.09.2023 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with, SI Srimanta Chatterjee, SI Mrinal Basunia, PSI Koushik Raha, SI Rantu Halder, ASI Dipak Karmakar, Const/1426 Prasanta Kumar Dutta and C/374 Debraj Biswas all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No- 1554 /23 Dt. 15.09.2023 to verify the veracity of information corresponding BKN PS/SPC, GDE.NO. 771 Dated. 15.09.2023 at the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 19.45 hrs on arrival at NH-31 bypass road, in front of Mama Hotel and waiting there. In the meantime I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Sujit Roy-30yrs s/o Uttam Roy of Lower Bhanunagar, , ward no-43, P.S- Bhaktinagar, Dist- Jalpaiguri, and (ii) Biju Sarkar-42yrs s/o Lt Ananda Sarkar of Lower Bhanunagar, , ward no-43, P.S- Bhaktinagar, Dist- Jalpaiguri also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of

law as witness. At about 20.10 hrs as shown and identified by the source, we found the above noted two persons were coming with a Royal Enfield motor cycle with huge injections and cough syrup in a yellow colour bag which was hanged on that motor cycle and we detained the above noted persons along with above noted articles at NH-31, in front of Mama Hotel under Bhaktinagar PS. We disclosed them our identity as police personnel. On being asked they disclosed their identity as noted above. On further examination the above alleged persons stated that they are possessing "Narcotics Substances" with them. Then I asked them whether they are wanted to be search in presence of an Executive Magistrate or any Gazetted Officer and they agreed to search by any one. I served them a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and apprehended persons to search our Police Party as per provision. But they refused to search by the police party. Then I informed the matter to special Executive Magistrate with written requisition through ASI Dipak Karmakar and requested him to come at NH-31, bypass in front of Mama Hotel under PS- Bhaktinagar to remain present and supervise the search and seizure as he being a special Executive Magistrate. After some time Special executive magistrate Sri Suraj Thakuri/ACP/HQ/SPC arrived at the spot. I disclosed the identity of Sri Suraj Thakuri/ACP/HQ/SPC to the apprehended persons and witnesses as a Special executive magistrate. Thereafter under the supervision Sri Suraj Thakuri/ACP/HQ/SPC and in presence of him and independent witnesses I conducted search of the above apprehended persons keeping strict regard and found the articles as per seizure list which was possessing by the apprehend persons. On being asked they further confessed in presence of Special executive magistrate and other witnesses that they procured the Narcotics Substance clandestinely for the purpose of selling to their designed Customers in order to earn huge amount of money for their wrongful gain. On interrogation they disclosed that they have been dealing in such illegal drug trafficking business and selling the same to the adjacent area of Bhaktinagar PS and hill side. On examination of the alleged apprehended persons noted above regarding any documents for carrying/possessing of said Narcotics Substance they failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Sri Suraj Thakuri/ACP/HQ/SPC I seized the articles under proper seizure list and Label under the supervision of Sri Suraj Thakuri/ACP/HQ/SPC in presence of witnesses duly signed by them as well as the accused persons and marked the seized exhibits as noted above.

The seizure and label was made between 22.25 hrs to 23.35 hrs. The whole process of search and seizure was video graphed by Sri Somnath Chatterjee of Arabindapally, Near Rathkhola PS Siliguri Dist Darjeeling.. Then I arrested the above noted accused persons u/s- 41 Cr.P.C after observing all formalities of arrest and disclosed them cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged person under proper receipt as the alleged accused person violated the terms and condition of N.D.P.S Act possessing injections and cough syrups without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely (1) Somnath Roy @ Hodol-30yrs s/o Lt Ananda Roy of Vidyachakro colony, ward No-44, P.S- Bhaktinagar, Dist- Jalpaiguri and (2) Balai Roy-34yrs s/o Lt Ananda Roy of Vidyachakro colony, ward No-44, P.S- Bhaktinagar, Dist- Jalpaiguri and arrange for its investigation.
