I am to inform you that while the Hon'ble Mayor was returning home after attending a programme at Surya Sen Mahavidyalaya, Siliguri, a passenger bus (Registration No. WB-71 9079 named "Surojit") which was heading towards NIP from Siliguri suddenly hit the Hon'ble Mayor's Car at a point between Dada Bhai Sporting Club and Subrata Sangha, Siliguri today, i.e. on 15<sup>th</sup> Sep 2023 around 5:53 PM causing considerable damage to the Hon'ble Mayor's Car bearing Regn No. WB-73 G 1059).
