Respected Sir,

With due respect I, **SMT. SHOBHA SARKAR**, Wife of Sri Madhab Sarkar, Resident of North Bharat Nagar, Near Shiv Bari, Ward No. 24 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin: 734006, would like to lodge this written complaint before your good office to the effect that since last 45 years, myself and my family members have been residing in the aforesaid address and presently, one tenant is also resided in our property. Since last two years, a group of young persons under the age between 20 to 30 years regularly gathered in front of our house in the evening time after 07.00/07.30 P.M. and they used to consume alcoholic products and other contraband articles including Ganja, Charas, Heroin etc. openly in the public place and nobody will dare to make any protest against their said illegal acts as usually they have gathered more than 20 persons together and they have possessed with arms and ammunitions.

Sir, previously, we have intimated the said facts to the Ld. Councilor of our Ward verbally and every time, our Ld. Councilor assured us that he will look into the matter and take necessary steps but finally, no fruitful result occurred and the miscreants regularly visited the said place and gathered there and also consumed alcohol and other contraband articles openly in public place and after consuming those contrabands, they showed their Dadagiri in the locality and also used to harass the innocent persons of the locality who used the said road.

Sir, yesterday i.e. on 18.09.2023, we have organized Biswakarma Puja in our house and in the evening time, guests were visited in our house to take the Prasad and at that time, the aforesaid miscreants under the leadership of **Kajal Sutradhar**, **Bapan Paul @ Baban** & **Shankar Sutradhar**, again came in front of our house and started to consume contraband articles openly in presence of public and also started to make halla, chaos and abused filthy languages in a loud manner and seeing the said situation, my younger son Sri Soumitra Sarkar went there and requested them not to consume contrabands articles openly and to leave the place as guests were visiting in our house on the occasion of Biswakarma Puja but they were not ready to hear the request of my son and after sometime, when my son and some of my guests


went there and requested them again to leave the place, they became furious and said **Kajal Sutradhar, Bapan Paul @ Baban and Shankar Sutradhar** are openly threatened my son and the guests and for a few moments, they left the place and thereafter at about 12.00 hrs. (midnight) the aforesaid persons along with one **Kala Chand Sutradhar along with 30 numbers of other unknown miscreants** have criminally trespassed into our house forcefully and started to ransack our property illegally and when I along with my husband and other family members have tried to restrain them from damaging our house property and other articles, they have started to assault me, my husband, my two sons and daughter-in-law brutally with the sharp cutting railway line stones and due to their said assault, we the every family members, have received severe injuries on our persons and they have also snatched my golden chain from my neck and other valuable articles from our house forcefully and when we started hue and cry, they left the place and at the time of leaving the place, they have threatened us with dire consequences by saying that if we inform the matter before any authority, they will not hesitate to ruin our life and property permanently and nobody will do anything against them.

Sir, my husband is a severe heart patient and one bypass surgery was made on his body and still now, he is undergoing treatment and due to the said assault of the aforesaid miscreants, my husband is still struggling with life and death and his condition is critical and we have been passing our days with extreme fear and mental anxiety. We also apprehend that immediately after lodging this complaint, they may come again and cause damage of our life and property.

I, therefore, request you to investigate into the matter and please take strong legal steps against the aforesaid persons as per the provision of law and oblige thereby.

Your early action is highly solicited.
