Sir,

It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC, being empowered by the Electricity Act 2003, do hereby lodge a complaint against KUSHIK MITRA, S/O- Lt Atindra Kumar Mitra, Address- Unique Apartment, Ghiyalal Sarani, North Mallaguri, Pin-734003 for direct hooking from the bus-bar of Unique Apartment.

Today i.e on 19.09.2023(14:00 hrs), I came to Unique Apartment, Ghiyalal Sarani, North Mallaguri, Pin-734003; in my official hired vehicle for a routine inspection. I was accompanied by (i) Pranab Sikder, S.O(S&LP), Darjeeling Region, (ii) Prakash Dutta, JE(Gr-II), Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the flat of KUSHIK MITRA located on the 2nd Floor is enjoying power illegally from the bus-bar by direct hooking. KUSHIK MITRA is a non-consumer.

I disconnected the illegal connection of KUSHIK MITRA & seized the isolator device along with wires used for hooking, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 1 isolator(63A) Make-HOSPER with two nos. of multiple strand flexible wire(blue color) of length 2 m approx(1.5 sq mm) and 2 m approx(2.5 sq mm) which was used for hooking purpose from bus-bar.

As such, KUSHIK MITRA, is enjoying power illegally in his flat by direct hooking from the bus-bar and is liable for prosecution U/S 135 1(a) of Electricity Act 2003 .
