Subject: Written Complaint

Respected Sir,

I, Smt. Radhika Khanal, Wife of Sri Tikaram Khanal, aged about 68 years, resident of Barpiapal Area, Sichey, Post Office & Police Station- Gangtok, East Sikkim, would like to bring the following facts to your kind notice:

That I am the sole and absolute owner of land measuring 5 (Five) Kattah or 0.083 acre appertaining to and forming part of Old Plot No. 228, corresponding to New L.R. Plot No. 489 and 490, recorded in Khatian No. 23 and new L.R. Khatian No. 259, situated at Mouza - Mahismari, J.L No. 47, Classification of land "Rupni", Pargana Patharghata, P.S. - Pradhan Nagar, Additional District Sub-Registry Office Siliguri II at Bagdogra, District: Darjeeling.

That today at about 08:00 a.m. I visited the above mentioned land and saw that some people namely (1) Sri Jagannath Gowala, Son of Late Chadara @ Chandarai Gowala and (2) Smt. Santi Gowala, Daughter of Late Chadara @ Chandarai Gowala, both are residents of Babubasa, Post Office - Champasari, Police Station: Pradhan Nagar, District: Darjeeling, Pin - 734003, (3) Sri Manik Das (Ashim), son of Birendra Das, resident of Debidanga (Behind Petrol Pump), Police Station: Pradhan Nagar, District: Darjeeling, Siliguri - 734003 and their associates have been trying to grab the below schedule land as well as disturbing the peaceful possession of the said land and they are trying to construct on the above mentioned land on the basis of some forged documents and they have already stocked some building materials viz. bricks, cement, iron rod, sand, bamboo, tin etc. in front of my land.


Immediately I protested the above illegal activities of the above noted persons and somehow managed to protect the land from them. They left the place but at the time of leaving the place they threatened me that they will come again and grab the land and neither anybody nor any law can prevent them from their illegal and unauthorized act.

It is right place to mention here that the above named Manik Das (Ashim) is a land mafia of the locality and several cases are pending against him at Pradhan Nagar P.S. for forgery of Government documents as well as grabbing the land. One G.R. Case No. 1699/2016 is also pending against him.

It is pertinent to mention here that I have filed a Civil Suit vide Title Suit No. 235 of 2015 which is pending before the Ld. Civil Judge (Junior Division) at Siliguri.

It is to be mentioned here that previously on 07/09/2021 the above named accused persons done the same sought of illegal act in same place and manner and at that time my lawful constituted attorney Miss. Deepa Rani Khanal lodged a written complaint before your P.S. and on the basis of the said complaint Pradhan Nagar P.S. Case No. 706 of 2021 dated 08/09/2021 under section 447/323/506/34 of I.P.C has been registered.

Under the above circumstances it is humbly prayed to your good self to be kind enough to accept this complaint and to take necessary strict and vigil action against as per law the above noted accused persons namely (1) Sri Jagannath Gowala, S/O - Late Chadara @ Chandarai Gowala and (2) Smt. Santi Gowala, Daughter of Late Chadara @



Chandaral Gowala, both are residents of Babubasa, Post Office – Champasari, Police Station: Pradhan Nagar, District: Darjeeling, Pin – 734003, Sri Manik Das (Ashim), son of Birendra Das, resident of Debidanga (Behind Petrol Pump), Police Station: Pradhan Nagar, District: Darjeeling, Siliguri – 734003 and their associates to save my land for the interest of justice.
