Sir,

In producing herewith 01 (one) arrested accused person namely Bhola Sarkar (30 yrs) S/O Jiban Sarkar of Bahadurtala More, P.O.- Beltala Park, PS- Balurghat, Dist- Dakshin Dinajpur A/P residing at the house of Mamatanand Sahani of Shivnagar, Darjeeling More, PS- Pradhan Nagar, Dist Darjeeling along with the following articles under proper seizure. The ground of arrest duly been communicated with him.

- (i) One packet containing 4.817 Kgs of said to be Ganja wrapped with white colour transparent plastic and white colour cello-tape and marked as "Exhibit- A".
- (ii) One packet containing 5.482 Kgs of said to be Ganja wrapped with blue colour plastic and white colour cello-tape and marked as "Exhibit- B".
- (iii) One black colour back pack style as "Royal Bags" and marked as Exhibit- "C".
- (iv) One black and blue colour back pack style as "Arya" and marked as Exhibit "D"  
(Exhibit "A" was kept inside Exhibit "C" and Exhibit "B" was kept inside Exhibit "D")

I, SI Bandhan Roy S/O Nanda Roy of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person namely Bhola Sarkar (30 yrs) S/O Jiban Sarkar of Bahadurtala More, P.O.- Beltala Park, PS- Balurghat, Dist- Dakshin Dinajpur A/P residing at the house of Mamatanand Sahani of Shivnagar, Darjeeling More, PS- Pradhan Nagar, Dist Darjeeling to the effect that on 19.09.23 at 20.10 hrs I, received a reliable specific source input that one person storing and selling huge quantity said to be Ganja at his rented house at Shivnagar under Pradhan Nagar PS to his design customers for his illegal gain. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS GDE No 1210 Dt 19.09.2023 and subsequently, I informed the matter to the Inspector-in-Charge, Pradhan Nagar Police Station in written. I also informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and directed him to come at Shivnagar under Pradhan Nagar PS with his video camera for the purpose of videography if required. Subsequently, being directed by Inspector-in-Charge, Pradhan Nagar PS, SPC I along with SI Youel Lepcha, ASI Biplab Kr Das, C/762 Majibul Rahaman and CV/992 Jagadish Biswas all of Pradhan Nagar PS, SPC left for Shivnagar under Pradhan Nagar PS by Govt. vehicle to verify the veracity of the information with investigation kits. This refers to Pradhan Nagar PS GDE No 1211 Dt. 19.09.2023 and M.C.C No 2337/23 date 19.09.2023. On the way I briefed all of them and share the information in hand. Under these circumstances any search warrant or authorization for search cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At about 20.35 hrs I along with above mentioned officers and force reached Shivnagar under Pradhan Nagar PS and contacted two independent witnesses namely i) Pawan Bhagat (19 yrs) S/O Raghu Bhagat of Shivnagar, Darjeeling more, PS Pradhan Nagar Dist Darjeeling and (ii) Rownak Singh (20 yrs) S/O Binod Singh of Shivnagar, Darjeeling more, PS- Pradhan Nagar, Dist Darjeeling and informed them about the source input and requested them in written to act as witness, if any search and seizure would be made necessary upon which they agreed. At about 20.55 hrs being pointed and identified by the source conducted raid and found the above noted person at his rented house. Thereafter, we disclosed our identity as police personnel and inform him regarding the information in hand and stated him that he will be searched in person for the said purpose.

On being asked he disclosed his identity as Bhola Sarkar (30 yrs) S/O Jiban Sarkar of Bahadurtala More, P.O.- Beltala Park, PS- Balurghat, Dist- Dakshin Dinajpur A/P residing at the house of Mamatanand Sahani of Shivnagar, Darjeeling More, PS- Pradhan Nagar, Dist Darjeeling and admitted that he has illegally possessed and stored Ganja at his rented room for selling and supplying the same to his designed customers as per their requirement on higher rate for his personal gain. I, then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. Accordingly, I informed the matter to the Inspector -In-Charge, Pradhan Nagar PS and as per his kind order, I informed the fact to Shri Suraj Thakuri, WBPS, ACP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day regarding interception of the accused person suspected to be possessed illegal Ganja and requested him to come at Shivnagar, near Darjeeling More under PS- Pradhan Nagar, Dist.- Darjeeling to remain present and to supervise the search and seizure.

Accordingly, at 21.35 hrs Shri Suraj Thakuri WBPS, ACP, Siliguri Police Commissionerate arrived at the spot Shivnagar, Darjeeling More under Pradhannagar PS. Then, I offered the independent witnesses and the detained person to search our Police Party as per provisions of law but they denied to search the police party. Thereafter, obtaining the permission from Shri Suraj Thakuri, WBPS, ACP, SPC and in presence of independent witnesses, I searched the detained person following all formalities, keeping his strict regard of decency and recovered (i) one packet containing said to be Ganja wrapped with white colour transparent plastic and white colour cello-tape, (ii) one packet containing said to be Ganja wrapped with blue colour plastic and white colour cello-tape, (iii) one black colour back pack style as "Royal Bags", and (iv) One black and blue colour back pack style as "Arya". SI No:(i) was kept inside SI No "(iii)" and SI No (ii) was kept inside SI No (iv) which were kept conceal below the bed of the detain person. On demand in presence of Shri Suraj Thakuri, WBPS, ACP, SPC as well the independent witnesses he failed to produce any valid documents/papers in support of seized articles. On further enquiry he admitted his guilt and stated that he had procured said to be ganja from Cooch Behar for the purpose of selling and supplying the same in high rates to his designed customers for his personal gain by illegal means and also stated that has been dealing such type of business of procuring and selling of Ganja illegally for last few months for his wrongful gain. Accordingly, I weighed the said recovered Ganja by Digital weighing instrument taken by us and found total 10.299 Kgs (4.817 Kgs + 5.482 Kgs) said to be Ganja in 02 (two) separate packets. Then, I seized, the entire articles viz (i) one packet containing 4.817 Kgs of said to be Ganja wrapped with white colour transparent plastic and white colour cello-tape and marked as "Exhibit- A", (ii) one packet containing 5.482 Kgs of said to be Ganja wrapped with blue colour plastic and white colour cello-tape and marked as "Exhibit- B", (iii) one black colour back pack style as "Royal Bags" marked as Exhibit- "C" and (iv) one black and blue colour back pack style as "Arya" marked as Exhibit "C". (Exhibit "A" was kept inside Exhibit "C" and Exhibit "B" was kept inside Exhibit "D") from the possession the above noted accused under proper seizure list in presence of in presence of Shri Suraj Thakuri, WBPS, ACP, SPC, and independent witnesses and obtain their signature and being acknowledged by the accused person. Subsequently, I labelled and sealed the seized articles in presence of Shri Suraj Thakuri, WBPS, ACP, SPC, independent witnesses and the above noted accused person. The whole process of search, seizure and label was made under the coverage of videography by the videographer named Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling in between 21.45 hrs to 22.25 hrs.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Bhola Sarkar (30 yrs) S/O Jiban Sarkar of Bahadurtala More, P.O.- Beltala Park, PS- Balurghat, Dist- Dakshin Dinajpur A/P residing at the house of Mamatanand Sahani of Shivnagar, Darjeeling More, PS- Pradhan Nagar, Dist Darjeeling is involved in procuring and selling Ganja illegally contravening the norms of NDPS Act. Then, I arrested the above noted accused person namely Bhola Sarkar (30 yrs) S/O Jiban Sarkar of Bahadurtala more, P.O.- Beltala Park, PS- Balurghat, Dist- Dakshin Dinajpur A/P residing at the house of Mamatanand Sahani of Shivnagar, PS- Pradhan Nagar, Dist Darjeeling after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the accused person namely Bhola Sarkar (30 yrs) S/O Jiban Sarkar of Bahadurtala More, P.O.- Beltala Park, PS- Balurghat, Dist- Dakshin Dinajpur A/P residing at the house of Mamatanand Sahani of Shivnagar, Darjeeling More, PS- Pradhan Nagar, Dist Darjeeling and arrange for its investigation.
