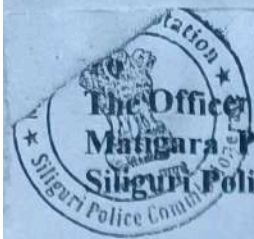

In producing herewith one arrested accused namely Apu Debnath (40) S/O- Sushil Debnath OF Vagni Part One PO+PS- Dinhata Dist- Cooch Behar present Address C/O- Dhananjay Das of Shivram Pally Ward No- 37 Haiderpara PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Fifteen (15) Bottles of Premium Tuborg Strong beer (each bottle containing 600 ML).

I, ASI Dhirendra Nath Mandal of Matigara PS, SPC lodged a written complainant against the above noted accused to the effect that today i.e. on 20.09.2023 hrs at 14:30 hrs received a source information that a person at Restaurant styled as "APNA DHABA" at 12 Gharia near ILS Collage PS- Matigara Dist- Darjeeling has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Matigara PS GDE no-1111 dated 20.09.2023. I informed to O/C Matigara PS about the information. As per his kind instruction I along with, C/523 Sanjit Kundu, CV/977 Gonesh Paswan, C/219 Sonam Chitrakar as proceed to at 12 Gharia near ILS Collage PS- Matigara Dist- Darjeeling to work on the information. At 14.45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the Restaurant styled as "APNA DHABA" and recovered the above noted articles from the possession of above noted accused person namely Apu Debnath (40) S/O- Sushil Debnath OF Vagni Part One PO+PS- Dinhata Dist- Cooch Behar present Address C/O- Dhananjay Das of Shivram Pally Ward No- 37 Haiderpara PS- Bhaktinagar Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Gopal Barman S/O Jharua barman of Ghogla jote PS-Matigara Dist-Darjeeling. I seized the above noted articles from the possession of above noted accused after preparing proper seizure list and took signature of the accused and witnesses. The seizure was made between 15.15 hrs to 15.45 hrs (total-09 Lts). I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused namely Apu Debnath (40) S/O- Sushil Debnath OF Vagni Part One PO+PS- Dinhata Dist- Cooch Behar present Address C/O- Dhananjay Das of Shivram Pally Ward No- 37 Haiderpara PS- Bhaktinagar Dist- Jalpaiguri under proper section of law and arrange for its investigation.
