Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1151 dated 21/09/2023 and informed the fact to the officer-In-Charge, Matigara PS and as per his direction myself along with, C/219 Sanatan Chitrakar and CV/977 Ganesh Paswan all of Matigara PS left for Matigara Biswas Colony, PS- Matigara, Dist.-Darjeeling to work out the information in hand. After arrival at Matigara Biswas Colony, PS- Matigara, Dist.-Darjeeling and being identified by the source we held raid at the residence of accused Ratan Barik and managed to apprehended him.
