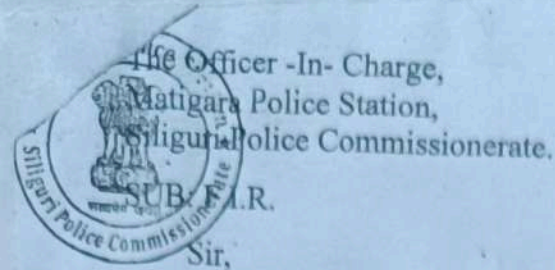



- 1. 10 (ten) seal Bottles of King Fisher Imperial Strong beer containing 600 MI each bottle marked as Exhibit "A" out of which 01 (one) seal bottle containing 600 MI taken as sample for examination and marked as Exhibit "A1".


I, ASI Pema Darjee Sharpa of Matigara P.S. SPC would like to lodge this written complaint against the above noted arrested accused namely Ratan Barik (51) S/O- Amulya Barik of Biswas Colony Matigara PS- Matigara Dist- Darjeeling to the effect that today i.e on 21/09/2023 at 08.35 hrs I received a specific source information that one Ratan Barik (51) S/O- Amulya Barik of Biswas Colony Matigara PS- Matigara Dist- Darjeeling is selling illicit liquor at his residence at Biswas Colony Matigara under PS- Matigara, Dist.-Darjeeling. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1151 dated 21/09/2023 and informed the fact to the officer-In-Charge, Matigara PS and as per his direction myself along with, C/219 Sanatan Chitrakar and CV/977 Ganesh Paswan all of Matigara PS left for Matigara Biswas Colony, PS- Matigara, Dist.-Darjeeling to work out the information in hand. After arrival at Matigara Biswas Colony, PS- Matigara, Dist.-Darjeeling and being identified by the source we held raid at the residence of accused Ratan Barik and managed to apprehended him. On being asked he disclosed his identity as noted above and also disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. On further being searched the above noted illicit liquor recovered from his residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned detained person named Ratan Barik (51) S/O- Amulya Barik of Biswas Colony Matigara PS- Matigara Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 09.15 hrs to 09.40 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Ratan Barik (51) S/O- Amulya Barik of Biswas Colony Matigara PS- Matigara Dist- Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
