An Application under Section 156(3) of Code of Criminal Procedure

The complainant above named begs to state as follows:

- 1. That the complainant is a senior citizen and he is the father of the accused.
- 2. That the complainant is a retired serviceman aged about 64 years residing at the above mentioned address in his own house and maintains himself by means of pension money.
- 3. That the above named accused is also living in the house of the complainant and is desperately involved in torturing the complainant.

- 4. That the accused person has been continuously torturing the complainant physically and mentally.
- 5. That the accused person has on several occasions locked the main gate of the house and thereby prevented the complainant from entering into his own house throughout the night and as a result complainant had to stay outside of his own house.
- 6. That the accused person all the time insults the complainant by using slangs and derogatory words and while protested by the complainant he was beaten by him brutally.
- 7. That on 19.03.2023 the accused person has snatched the key of four wheeler swift car which belong to the complainant being Reg. No. WB 74 BA 6015. When the complainant protested against the said act the accused person started punching and kicking the complainant. And threatened him with dire consequences.
- 8. That thereafter the complainant went to the Siliguri District Hospital the prescription thereof has been enclosed with the instant complaint.
- 9. That thereafter the complainant went to the Pradhan Nagar Police Station and lodged a written complaint to that effect. But the police authority has not taken any action in this regard.
- 10. That till date the said car has been misappropriated by the above named accused person.
- 11. That thereafter on 16.08.2023 the complainant lodged a written complainant in the Siliguri Police Commissionerate under Sec. 154(2) of the Cr.P.C. But no necessary legal action has been taken by the concerned authority.
