Sir,

It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against PADMA DEVI AGARWAL, W/O-SHYAM SUNDER AGARWAL, Address- SBM Bliss, Utpal Nagar, Dhaknikata, Pin-734003 for direct hooking from the bus-bar of SBM Bliss.

Today i.e on 20.09.2023(12:40 hrs), I came to SBM Bliss, Utpal Nagar, Dhaknikata, Pin-734003; in my official hired vehicle for a routine inspection. I was accompanied by (i) Prakash Dutta, JE(Gr-II), Pradhannagar CCC (ii) Rabi Sankar Singh, O.E, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the flat of PADMA DEVI AGARWAL located on the 1ST Floor is enjoying power illegally from the bus-bar by direct hooking. PADMA DEVI AGARWAL is a non-consumer.

I disconnected the illegal connection of PADMA DEVI AGARWAL & seized the wires used for hooking, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 2.5 sq mm flexible copper wire(green) 6m approx ion sample basis which was used for hooking purpose from bus-bar.

As such, PADMA DEVI AGARWAL, is enjoying power illegally in her flat by direct hooking from the bus-bar and is liable for prosecution U/S 135 1(a) of Electricity Act 2003 .
