

I Sri Sanam Rai, s/o Sri Tej Bahadur Rai, Resident of Gulma Tea Estate, Fitter line, Po - Gulma, dist - darjeeling beg to state that on 18/9/23 at around 10:30 PM my aboved named father was on the way to home from Biswakarma Pujar near Milan Singh club at the village. Suddenly a pick up van bearing Ref. no WB 73C 7002 lost its speed during gearing back and dashed my father from his back side that caused severe injury to him. He (my father) was instantly taken to the Gulma Hospital but the injury was grievous in nature and as such he was forwarded to any better hospital or nursing home from the Gulma Hospital. Later he (my father) had been admitted in North Bengal Neuro Hospital (Pradhan Nagar) and he is still now under treatment therein.

The involving driver Sri Abinash Baraik s/o Sri Arjun Baraik being the local man could not fled. The villagers did not allow him to take the vehicles from the village and since the vehicle is standing at the village. However we were so busy for the treatment of our father, FIR could not be lodged in time. I shall be thankful if you kindly lodge the matter stated above as an FIR and do the needful in this regard. 1
