Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Bhola Barai (40 yrs) S/O Suklal Barai of Debidanga Bazar, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and 01 improvised small Fire arm (one shooter) measuring 24.5 cm in length including its 14 CM barrel, and 8 cm wooden Butt with one trigger, striking hammer, striking pin in working condition with 01 (one) round live ammunition. The ground of arrest duly been communicated with him.

I SI Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted arrested accused person namely Bhola Barai (40 yrs) S/O Suklal Barai of Debidanga Bazar, PO- Champasari, Dist.- Darjeeling. In this regard, I beg to report that today i.e. on 21.09.23 at 22.10 hrs I received a secret information that one Bhola Barai of Debidanga Bazar is moving at Debidanga Bazar under PS- Pradhan Nagar, Dist.- Darjeeling with improvised fire arms loaded with live ammunition most probably for committing heinous crime. Accordingly, I Diarised the information in General diary vide Pradhan Nagar PS GDE No 1358 dated 21.09.2023 and informed the fact to you. As per your kind order and direction myself along with ASI Biplob Kr Das, ASI Monoj Kr Roy, C/762 Majibul Rahaman, CV/645 Pankaj Gupta, Cv/128 Ajoy Kr Sahani and CV/242 Rakesh Monger all of Pradhan Nagar PS, SPC left for Debidanga Bazar under PS- Pradhan Nagar, Dist.- Darjeeling with investigation kit to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Debidanga Bazar at about 22.25 hrs and as indicated by the source we able to apprehend one person. On being asked he disclosed his identity as noted above. As per source information, that he possessed improvised fire arms with ammunition. Hence, immediately, I searched the detained person and recovered 01 improvised small Fire arm (one shooter) with trigger, striking hammer, striking pin loaded with one ammunition which accused kept concealed in his waist. He exclusively possessed improvised fire arm loaded with ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm and live ammunition which has been found in his possession. Thus, when his involvement in carrying and possessing illegal fire arm and ammunition was established, I seized that improvised fire arms measuring 24.5 cm in length including its 14 CM barrel, and 8 cm wooden Butt with one trigger, striking hammer, striking pin in working condition and marked as "Exhibit-A" and 01 (one) round of live ammunition marked as "Exhibit-B" under proper seizure list in presence of available witnesses and duly signed and acknowledge by the accused person in between 22.45 hrs to 23.25 hrs on 21.09.23 and subsequently arrested him by preparing memo of arrest informing him about the ground of arrest.


Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the said accused person namely Bhola Barai (40 yrs) S/O Suklal Barai of Debidanga Bazar, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling is desperate and dangerous in nature, as he was carrying the said fire arm and ammunition with an objective to commit heinous crime in the locality.

As he willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the said arrested accused person namely Bhola Barai (40 yrs) S/O Suklal Barai of Debidanga Bazar, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling under appropriate section of law and arrange for its investigation.
