Respected Sir,

I. Ashim Kumar Ghoshal, S/o. Late Jiban Krishna Ghoshal, R/o. Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling West Bengal, India, would like to state that my son namely Subhojit Ghoshal (now deceased) is a owner of TVS Scooty bearing registration No. WB-74BG-5999. Before his demise i.e. on 13/08/2023 at about 2.00 P.M. my son kept his TVS Scooty bearing registration No. WB-74BG-5999 at the parking of his flat at Hakimpara, Siliguri. Later after sometime when he came back he was surprised to see that my scooty was not there where it was kept. Before lodging any FIR, my son informed the matter to me but suddenly my son felt ill and died. There was an apple series 7 watch 45 MM QCXL7Y5217 & a duplicate key of the scooty inside the dickey of the scooty. Suspected person namely Mitra Ghosh, Aged about 60 years and her daughter (accused of stealing of Scooty from the building). As my son Subhojit Ghoshal suddenly felt ill & died at Astha Nursing Home, Medical More, District Darjeeling on 06-09-2023 at about 6.15 P.M. hence I could not complaint the matter to the local Police Station in time. Due to this the delay of FIR has been lodged as the health condition of my son was not good so could not lodged the FIR.

It is requested before you in folded hand to kindly take strict necessary action against the miscreants so that my scooty can be recovered. The details of the scooty is as follows:-
