Dear Sir,

With due respect I Mahuya Raha Dalal, W/o. Sri Kalyan Raha, resident of 112, Rajiv Gandhi Street, Surya Nagar, P.S Siliguri, Dist. Darjeeling, would like to inform you that, my husband has two brothers namely Sri Arun Pada Raha and Sri Tarapada Raha and one sister namely Smt. Gayetri Majumder and after the demise of my father in law, my husband and one of my brother in law Sri Tarapada Raha both family members are reside together in an unpartitioned house of my deceased father in law. My elder brother in law Sri Arun Pada Raha who is an advocate of Siliguri Court and practicing as a tax consultant who resides separately just near of my matrimonial house since more than 23 years with his family members and he never came to my matrimonial house without any reason or any family function.

I would like to further inform you that some days before my elder brother in law Sri Arun Pada Raha sent a legal notice through an advocate to my husband, my another brother in law and my sister in law, stating that he wants to physical partition of my matrimonial house as per Hindu Succession Act.

I would like to further inform you that, today at about 4 p.m. my elder brother in law Sri Arun Pada Raha alongwith his wife Ranju Das Raha came to my matrimonial house and suddenly they have locked a door by putting a padlock where a municipality water connection is there, seeing the said unnatural behaviour my husband and my another brother in law asked my elder brother in law and his wife as why they did unnatural behaviour and showing arrogant nature without any rhyme or reason, suddenly said Arun Pada Raha and his wife became very furious and started to used abusive languages and he also started to beaten upon my husband by fist and blow and for that my husband sustained injury in his various parts of body, hearing the loudness I came out from my house and I shocked to see that my elder brother in law takes a broken glass in his hand and he stabbed upon my husband with an intention to kill my husband but somehow my husband tried to save himself and for that his right hand cut off very badly and started to bleeding from his hand seeing the said incident I started to shout but my said brother in law started to beaten me also by pushing me in my chest and for that I also sustained injury and said Sri Arun Pada Raha also tried to molestation. Thereafter said Arun Pada Raha and his wife Smt. Ranju Das Raha entered into my house forcibly and started to thrown out all valuable articles and he also broke my some expensive trees and tubs which is my business part amounting Rs. 19,000/-, and they also threatened us that said Arun Pada Raha will destroy our lives as he belongs from the advocate society and no one can do anything against his will.

It is needless to mention here that, my elder brother in law also broke window glasses of my neighbour by throwing one of my plant and tub.

Thereafter, I brought my husband to Siliguri Sadar Hospital and treated him and two stitches given in his hand and other necessary treatment has been given.

Under the above circumstances I would like to request you to investigate the matter and do necessary action against my said brother in law and his wife and they may punished according to the law for the ends of justice.
