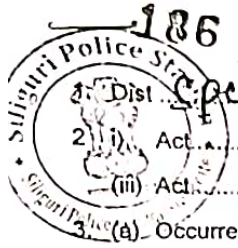

I went to my another house situated at Rajib Gandhi Street by Lane, 1No. Dabgram, Suryanagar, Ward No. 23 of Siliguri Municipal Corporation, bearing holding Number 112/168/I, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, 734006, which was the father's property and after demise of my father & mother me & my two brother Tarapada Raha @ Swaran Raha, Kalyan Raha and my married sister Gayatri Majumdar (Raha) were jointly inherent the entire property in equal 1/4th undivided share. At 04:30P.M. today i.e. 21.09.2023 when I went to that Rajib Gandhi Street house my brother Kalyan Raha, Son of Late. Kali Pada Raha, residing at Rajib Gandhi Street by Lane, 1No. Dabgram, Suryanagar, Ward No. 23 of Siliguri Municipal Corporation, bearing holding Number 112/168/I, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, 734006, try to obstructed me when I asked the reason for that my brother claim that the entire property is belong to him and after that I protest of such unlawful act and my brother suddenly hit my face with a punch as a result my eye glass was broken, I am 70 years of old and being an Advocate I did not lose my temper and again as a big brother I try to cool down the situation but my brother lose his temper and again push me heard as a result I laid down to the ground thereafter he bitten me badly with his leg and used filthy languages and thereafter he pull my collar and snatched my golden chain and thrown it away and my brother not stop yet thereafter suddenly bring out a sharp knife from his back and try to kill me and shouted badly then neighbours were came to rescue me and help to neibours I able to survive my life.

It is also mentioned here that due to partition of our inheritance land I send one legal notice through my engaged lawyer Pratik Panda on 06.09.2023 to my brother Tarapada Raha @ Swaran Raha, Kalyan Raha, and my sister Gayatri Majumdar (Raha) for partition the our inheritance property situated at Rajib Gandhi Street by Lane, 1No. Dabgram, Suryanagar, Ward No. 23 of Siliguri Municipal Corporation,
