Sir,

In producing herewith one arrested accused person namely DEB DAS @ KANAI-24YRS S/O MONORANJAN DAS OF DASARATHPALLY, WARD NO-44, PO SEVOKE ROAD, PS BHAKTINAGAR DIST JALPAIGURI along with the following seized articles as per proper seizure list viz:

- (1) 21(Twenty one) bottles of HIT strong Beer (Made in Sikkim) each bottle containing 650 ML which was kept in one big nylon hand bag.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 21.09.23 at 15.55 hrs received a source information from Behind Payel cinema, near TB Hospital under Bhaktinagar PS that one person namely Kanai Das was standing with huge quantity of liquor in his possession at above noted place for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1090 dated 21.09.23. As per your kind order myself along with PSI Koushik Raha, ASI Chandra Prakash Chhetri. C/374 Debraj Biswas, CVF/014 Labannomoy Barman, CVF/614 Sumit kumar Roy, proceeded to the PO to work out the information. At 16.20 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession which was kept in his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him u/s 41 Crpc after issuing proper arrest memo (The seizure was made in between 16.45hrs to 17.50 hrs)

I therefore request you a specific case may kindly be started against the accused person namely DEB DAS @ KANAI-24YRS S/O MONORANJAN DAS OF DASARATHPALLY, WARD NO-44, PO SEVOKE ROAD, PS BHAKTINAGAR DIST JALPAIGURI under proper section of law and arrange for investigation..
