Sir,

In producing herewith one arrested accused person namely Chandan Mandal(46yrs) S/o. Lt.Basudev Mandal of Mahamaya colony, Po Kamarvita PS NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list

1. 30(thirty) sealed Bottles of Galaxy Boss 60 UP Country Spirit containing 300 ml each.

1. ASI Rana Jadav of Ambari Falakata Out Post under NJP PS/SPC lodged a complaint against the above noted person to the effect that today on 23.09.2023 at 16:05 hrs received a source information from Mahamaya colony area, under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at Mahamaya colony for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE No. 915 dated 23.09.23. I informed to O/C Ambari Falakata Out Post about the information. As per his kind instruction I along with, (1) C/322 Jayanta Roy and (2) NVF/130 Danadev Roy both of Ambari-Falakata OP, Under NJP PS/SPC proceed to Mahamaya colony area under Ambari-Falakata OP to work out the information. At 16:25 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Mahamaya colony and recovered the above noted articles from the possession of accused person namely Chandan Mandal(46yrs) S/o. Lt.Basudev Mandal of Mahamaya colony, Po Kamarvita PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person in presence of witnesses namely (1) Tarzen Roy S/o. Norma Roy of 09 Colony, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri and (2) Abijit Majumdar s/o Lt. Asim Majumder of Mahamaya colony, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri. The seizure was made between 17:05 hrs to 17:40 hrs. Then I arrested the said person u/s 11 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Chandan Mandal(46yrs) S/o. Lt.Basudev Mandal of Mahamaya colony, Po Kamarvita PS-NJP, Dist- Jalpaiguri under proper section of law.
