I, Sukla Roy Mallick, W/o. Ujjal Roy, resident of Pokhajote, Ward No.46, P.O.- Champasari, Dist.- Darjeeling- 734003, would like to inform do hereby lodging this FIR and narrating the facts and circumstances with a request to take appropriate legal steps against the below mentioned culprit for saving my life as well as for the safety and securities of my entire families.

I am married wife of Ujjal Roy, son of Adhir Chandra Roy. That yesterday on 25/09/2023 around 9.30pm to 10pm when I was alone at my home in absence of my husband My Father-in-law Adhir Chandra Roy suddenly enter in my room and asking for keys of car, on denials that I have no knowledge about that, Adhir Chandra Roy(my father-in-law)become furious and started physically torture me by hitting, slapping, and pushing me out from my room by using filthy languages and outrage my modesty. When I shouted my mother-in-law(Ratna Roy) come to my room and try to save me. But my father-in-law is so much dangerous and cruel he started to beat severely my mother-in-law by blow and kick and threatened us to kill my whole family ,My mother-in-law, even my 5years son. Somehow we close my rooms doors and save our life.

That after my marriage my father-in-law namely Adhir Chandra Roy used to physically assaulted me by hitting, slapping, and pushing me without any provocation This incident resulted in immense psychological trauma. Since long I have been subjected to a constant

barrage of derogatory and demeaning language by my father-in-law. His verbal assaults have included offensive remarks, threats, and humiliation, which have had a detrimental effect on my mental health. My father-in-law engages aggressive nature and cruelty to control and dominate me, my husband and my Mother in law. He frequently uses slang languages threat, demand dowry from my parents. Exert power and instill fear within me, my husband, (Ujjal Roy) and my mother in law (Ratna Roy) to make us homeless.

On dated 02/07/2023 i.e, Sunday at around 12 pm in presence of Councilor of Ward No.46 a meeting was held at our home regarding the above mention issues but nothing was fruitful, my father-in-law is so adamant and become cruel and violent in nature.

Under the above circumstances I want to inform you that most of the time my husband used to stay outside due to work, I stay at my husband's house with my small child (5 years old) and with my mother in-law. Due to aggressive and dishonest intention of my father in law any unwanted situation may happened at any time. I, my husband and mother-in-law getting insecure of life. If any unnatural things happened in future my Father in law and brother in law will be fully responsible.

I want to emphasize that these instances of domestic violence have been witnessed by my spouse (Ujjal Roy), mother-in-law (Ratna Roy) as well as other family members and friends who can attest to the authenticity of my claims. Please take necessary steps as early as possible.
