**SUB:- LODGING OF FIR**

It is to intimate that, On 21.09.23 on a specific source info, No- 163501936 SI Parveen Pardhan along with SOs-02 and ORs-02 detailed for depth area domination and the party left BOP Fulbari at 210200 hrs for depth area PTLG.

At about 0430 hrs, the PTLG party observed some suspicious movement of miscreants along with cattle in the tea garden behind IBBR in the depth area between BFL No. 13 & 14 in alignment of BP No.732/4-S in the AOR of BOP Fulbari. They were approaching towards the IBBR with the motive to smuggle cattle from India to Bangladesh. The PTLG party rushed towards the spot and challenged the advancing miscreants. On seeing the PTLG party, the miscreants ran away towards village Pradhanpara by taking advantage of bad weather and darkness. PTLG party searched the area and seized 08 Bengali origin medium size cattle Rs. 14459\*08 worth Rs 115672/- as outgoing/unclaimed in depth area and further handed over the seized cattle to Dhyhan Foundation, Bhootnath Goushala, Kishanganj (Bihar) on 24.09.2023 .

As per the info of reliable sources, following Indian smugglers were involved in the above incident-

1. Harun Rashid (age-27 years) S/O MD Mustafa, Vill-Sardarpara, PO-Nakugach, PS-Rajganj
2. MD Amhad ( age-35 years ) S/O Anarul Islam, Vill-Bhulrivitta, PO-Nakugach, PS-Rajganj
3. MD Bukul (age-28 years ) S/O Parbasu, Vill- Bhulrivitta, PO-Nakugach, PS-Rajganj

It is to mention here that the above mentioned miscreants earlier also involved in various illegal activities and Trans border crimes and BSF has lodged many complaints against them.

In view of the above, you are requested to lodge a FIR against the above mentioned miscreant and take a stern action against them. It is also requested to provide the copy of the FIR and intimate the outcome of the case to the Coy accordingly.
