Sir,

It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **GOVIND BHADRA(USER)**, S/O- Lt **DIPEN BHADRA**, Address- Champasari Main Road(near Coal Depot) Pradhannagar, Pin-734003 for unauthorized use of domestic meter(TO3153065) of WBSEDCL for commercial purpose.

Today i.e on 27.09.2023(14:00 hrs), I came to Champasari Main Road(near Coal Depot), Pradhannagar, in my official hired vehicle for a routine inspection. I was accompanied by (i) Pranab Sikder, S.O(S&LP), Darjeeling Region, (ii)Rabi Sankar Singh, OE , Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the domestic meter TO3153065 (Con Id- 412060872) was unauthorizedly being used for commercial purpose (Commercial Establishment viz.MAA JAGADAMBA TRADERS).

I disconnected the connection & seized the meter, after preparing the seizure list duly signed by the witnesses.

Seized Articles:

- One 1-phase energy meter TO3153065 (P/R-8135) Make-L&T, 240V , 5-30 amp

Sri **GOVIND BHADRA(USER)** was present at the site and received the copy Notice, Inspection Note & Seizure list.

As such, **GOVIND BHADRA(USER)** has committed unauthorized use of electricity, other than the one intended for.

Please treat this complaint as FIR U/S 135 1(e) of Electricity Act 2003 against **GOVIND BHADRA(USER)**.
