Sir,

In producing herewith one arrested accused person named Sridam Halder (40 yrs) S/O Lt Debendra Nath Halder of Dakshin Palash, Natun Bazar, PS- Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

- (i) 18 (eighteen) Bottles of Old Monk Deluxe Rum containing 750 Ml in each bottle (total 13.5 ltrs) Blended & Bottled by Pristine Distilleries, Hollongi, Koklla Road, Sahjan Papun Para, Arunachal Pradesh and marked as Exhibit "A" and 01 bottle Bottles of Old Monk Deluxe Rum containing 750 Ml taken as sample for examination and marked as Exhibit "A1"

I, ASI Monoj Kr Roy of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted arrested accused namely Sridam Halder (40 yrs) S/O Lt. Debendra Nath Halder of Dakshin Palash, Natun Bazar, PS- Pradhannagar, Dist. Darjeeling to the effect that today on 27.09.23 at 20.10 hrs I received an telephonic information from one person of Dakshin Palash that one Sridam Halder of Dakshin Palash under PS- Pradhan nagar, Dist.- Darjeeling stored huge quantity of Sikkim made and Bhutan made liquor at his residence with a view to sale the same to common people for his illegal gain. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS- GDE No 1723 dated 27.09.23 and informed the fact to the I/C, Pradhan Nagar PS and as per his kind order and direction myself along with force left for Dakshin Palash to verify the veracity of the information in hand. After arrival at the house of said accused at Dakshin Palash, Natun Bazar, Ps. Pradhannagar, Dist. Darjeeling, huge numbers of local people came to police and reported that the said accused Sridam Halder continuously running this illegal business at his residence since long and on protest by the local people he threatened common people with dire consequence. Accordingly, I entered into the resident of said Sridam Halder and managed to apprehended him. On being asked he disclosed his identity as noted above. On interrogation he disclosed that he is storing illegal liquor at his residence. On search the above noted articles recovered from his possession. On demand he failed to produce any valid license/papers for selling and storing of such articles at his residence. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Accordingly, I seized and labelled the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and subsequently, arrested the above mentioned person named Sridam Halder (40 yrs), S/O Lt Debendra Nath Halder of Dakshin Palash, Natun Bazar, PS- Pradhannagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21.05 to 21.50 hrs. After consultation of PS record it is learnt that on 20.09.2023 the said accused was arrested and a specific case was registered at this PS vide Pradhan nagar PS Case No 759/23 dated 20. 09.23 U/S 46A(c) of Bengal Excise Act.

Under the above noted fact and circumstances I, pray before your good self that specific case may kindly be initiated against Sridam Halder (40Y/M), S/O Lt Debendra Nath Halder of Dakshin Palash, Natun Bazar, PS- Pradhannagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
